





At the solicitation of your State Legislative committee, I drew up and forwarded to Gov. Powell a resolution embodying my idea of the instructions which should be given to Senator Vance. The resolution contemplates its adoption and the reply of Vance before he can-
cuss meets. This I regard as all important. I do not stickle for the particular form of the sub-treasury bill, but simply instruct him to favor and vote for such measures for financial relief as embody the essential principles of that bill, and then ask his response to the same.


