Prendergast, who murdered Mayor Harrison, of Chicago, Illinois, some time ago was put on trial for his life last week and on Friday the jury returned a verdict of murder in the first degree and recommended that he be hanged. The verdict was reached after a deliberation of a little over an hour. Prendergast merely crossed his legs, not uttering a sound, when it was announced. When the judge, jury and court officers took their places in court and the prisoner was brought in, his bravado, and vanity had fled, and he stood before court and jury a cringing coward, afraid to hear his doom pronounced. He dropped into his seat against the wall and the guards stood over him. A pallor spread over his face and he stared vacantly in front of him. The judge broke the silence by asking, "Have you agreed upon a verdict gentlemen?" He was answered by the foreman of the jury, "We have," and handed the clerk of court a document which he began reading slowly and distinctly as follows: "We, the jury, find the defendant Patrick Eugene Prendergast guilty of murder in the manner and form as charged in the indictment and we fix his punishment at death." As the clerk uttered the word "death," Prendergast made the Catholic sign on his breast with his right hand. After the removal of the prisoner Attorney Wade made a formal motion for a new trial which will be argued next week. Better let him hang and be done with it.

The old year with all that it gave us of joy or sorrow, of pleasure or disappointment, of success or failure, is in the dead past, and now we are in the living reality of a New Year. If the failures of the past year ascended the successes, if our sorrows outweighed our joys, let us forget these and turn our eyes in hope to the New Year. Forget the past and brood not over it. No man ever accomplished aught who sat down to lament the past, and what might have been. He wins the prize who always forges ahead. So if anyone is discouraged over the disappointments and failures of the past, let him cheer up and start out anew with a determination to succeed.

The United States war vessel Indiana which is nearing completion, will be fitted with the heaviest nickel steel armor in the world. It will be impossible for a bullet to penetrate it. It is seventeen inches thick. The total weight is about 1,000,000 pounds and it would take an army of 4,000 men, they using their utmost strength, to lift her. The Hotchkiss and Duggs-Shroeder guns of eight six pounders will constitute her battery, and they can easily pepper an enemy's deck with shot at the rate of 150 a minute, rendering it impossible for the enemy to harm her unless they protect themselves behind bomb-proof devices.

It seems as if the Corbett-Mitchell price fight will not come off at Jacksonville, Fla., on the 26th of January, as anticipated. Gov. Mitchell says the fight shall not occur except under decision of the Supreme Court. The Duval Club, under whose auspices the fight was to take place will test the legality of the law. They seem confident they will win.

Bradstreet's Journal last Saturday summing up the reports of unemployed men in 119 cities from which replies to enquiries had been received, makes the total 801,055, and the number dependent 1,956,110. Among these are 20 Southern cities with a total of only 42,065, and dependent 122,650, which is a comparatively good showing for the South.

Mr. John W. Jenkins, who has for some months been associate editor of the Raleigh Christian Advocate, recently severed his connection with that paper and has purchased the Durham Globe. He is an intelligent young man, a good writer, and will meet with success.

In the numerous appointments Collector Simmons is making to fill the various revenue positions under him, we notice that Pitt county is conspicuously out of it. It strikes us, however, that Pitt is usually on hand when election time comes around.

Charlotte has humped herself up and had a great big professional baseball game right here in the dead of winter and in the midst of the foot ball craze. But Charlotte is never behind.

We are indeed sorry to learn of the sickness of Dr. T. B. Kingsberry, editor of the Wilmington Messenger and hope he may soon be at his post again. He has a gripple.

The National Treasury is reported to be getting lower and lower. Hurry up the income tax and it will get to climbing again.

WASHINGTON LETTER.

(From our Regular Correspondent.)

WASHINGTON, D. C., Jan. 1, 1894.

The use of money to defeat the Wilson tariff bill is the dominant idea of those who have grown rich at the expense of the consumers of the country by reason of the so-called protection legislation of Republicans. Returning Democrats to Congress from districts having protected manufacturers all agree in saying that money is being freely spent by those manufacturers in order to work up a bogus public sentiment in the columns of the Wilson tariff bill, hoping thereby to influence the Representatives to vote against the bill. Not only are halls hired for meetings to be held to protest against the bill, but individuals are employed by the hundred to come to Washington, and to get signature at home to petitions asking that the bill be not passed, and space is bought in the columns of impetuous newspapers which claim to be independent which is filled with shrewdly-written articles adapted to the locality and intended to frighten the ignorant into the belief that the passage of the Wilson bill will be a local calamity of incalculable magnitude.

All of these things were expected. The Democrats knew that the men who had grown rich by legislation would not see that legislation upset without spending a part of their easily-acquired wealth to prevent it. But the money is wasted as for as its influence upon Democratic Congressmen is concerned. It is easy to find Democratic Congressmen who would like to change some schedule in the Wilson bill and who propose to state their reasons for desiring a change to the Democratic caucus soon to be held and ask that it be made, but the number of Democrats who will refuse to vote for the bill if the caucus does not agree with them can be counted upon the fingers of one hand with fingers to spare. They generally recognize the fact that the Wilson bill is a party, not an individual measure, and that as good Democrats it is their duty to support the Democratic caucus, and they will do it. No party measure has ever been passed by Congress which did not receive the votes of men whose personal inclinations and interests were opposed thereto and none ever will be. When a man cannot bring himself to vote for a party measure, particularly when it represents tariff reform, which has been the keystone of the Democratic arch so many years, it is high time that he should cease to call himself a party man or to expect to receive honors from the party he declines to support.

The presence of several Democrats who would be willing to preside over the Government Printing Office, together with the knowledge that the period covered by the bond of the Republican Public Printer will expire at midnight of next Sunday, makes it look as though the appointment of a new Public Printer would very shortly be made. The Democrats have waited very patiently for this change to be made, as they are more places outside of the civil service rules in that Office than in any other single branch of the government. To have heard some of the men who think themselves entitled to advance knowledge of all the President's movements talk this week a foreigner would have supposed that President Cleveland committed a great crime when he went down the river in company with Secretaries Gresham and Carlisle for several days recreation without telling his would-be guardians beforehand. The antics of these smart alecks would be amusing if they were not so absurd.

Representatives McMillan, of Tennessee, and Bryan of Nebraska, who were appointed a subcommittee by Chairman Wilson to report to the Democrats of the Ways and Means committee of the House the features of the internal revenue bill that is to make up the deficit that will be made in the revenue of the Government by the Wilson tariff bill, have decided upon their report. It will recommend that a tax of 2 per cent be imposed upon all incomes of \$4,000 and over; that a tax be imposed on inheritances of personal property, the rate to be fixed later; that the tax on cigarettes be increased to \$1.50 per 1000, and that a tax of 6 cents a pack be levied on playing cards. They estimate that a bill on these lines will bring in about \$45,000,000.

A subcommittee of the Senate committee on Foreign Relations, composed of Senators Morgan, Butler, Gray, Sherman, and Frye, this week began the Hawaiian investigation authorized by Senator Morgan's resolution. They heard several witness friendly to the provisional government and adjourned until next Tuesday, when other witnesses will be heard. Nothing will be made public until the work is finished and the report of the committee made.

THE DISASTROUS YEAR OF 1893.

New York, Dec. 30.—R. G. Dun & Co's weekly review of trade and industry for the year 1893, says:

Starting with the largest trade ever known, mills crowded with work and all business stimulated by high hopes, the year 1893 has proved, in sudden shrinkage of trade, in commercial disasters and depression of industries, the worst for 50 years. Whether the final results of the panic of 1837 were relatively more severe the scanty records of that time do not clearly show. The year closes with prices of many products the lowest ever known, with millions of workers seeking in vain for work, and with charity laboring to keep back suffering and starvation in all our cities. All hope the new year may bring brighter days, but the dying year leaves only a dismal record.

The review of the different departments of trade, given to day exhibits a collapse of industry and business which is almost without precedent. The iron industry still leaves 40 per cent. of the force unemployed. Over one-half the woolen manufacture is idle and excepting a brief recovery in November, has been since new wool came in May, the price having fallen 20 per cent. for fleece to the lowest point ever known. Sales of cotton goods are fully a quarter below the usual quantity. The small advance shown in boots and shoes a year ago was not sustained, but with prices as low as ever, the shipments of boots and shoes from Boston are 24 per cent. less than last year. In December not only manufactured goods as a whole but the most important farm products are so low that producers find little comfort.

Clear evidence of the shrinkage in different branches of business is afforded by answers already received to several thousand circulars requesting figures of sales during the last half of 1893 and '92. Full information of the results will be given hereafter, but returns of textile goods already show a decrease of 37 per cent. Iron returns thus far show a decrease of 33 per cent. Reports thus far of jewelry show a decrease of 29 per cent; furniture 26 per cent; dry goods 20 per cent; less than last year. In December not only manufactured goods as a whole but the most important farm products are so low that producers find little comfort.

It is curious that the only trade showing any increase as yet in groceries, the aggregate sales being 1 per cent larger than in the last half of '92. In the 37 years recorded by the records of this agency, the number of failures has only once risen a little above 16,650 in a year. In 1893 the number reported has been 16,659. The aggregate of the liabilities in all failures reported has in six years risen over \$200,000,000. This year the strictly commercial liabilities alone have exceeded \$331,422,939, the liabilities of banking and financial institutions have been \$510,956,864, and the liabilities of railroads placed in the hands of receivers about \$1,212,217,833. As all the reports hitherto have been to some extent erroneous, through inclusion of failures not strictly commercial, the classified returns show 3,226 manufacturing failures, with liabilities of \$164,707,449; 10,683 failures in legitimate trade, with liabilities of \$88,527,896, and 392 other failures, including brokers and speculators, with liabilities of \$30,662,735. The average of the liabilities in manufacturing is \$5,400; in legitimate trade, \$8,000; and in other failures \$11,000.

Resolved, Around the council of Wapokoneta Tribe, that in his death our Order has lost a fearless and tireless worker, a useful and worthy member, and a brother whose sole aim was to inculcate and advance the true principles of Redmanship, leaving behind him a record, for his period of membership, worthy of the emulation of every brother, but not easy of attainment.

Second, That as a member, all that was assigned to him was safe and secure; a devotee at the shrine of the Order, with him no failures, no reverses, none superior, few equal.

Third, We are here in council reminded that if we are to teach, we must meet him again. That typical, though unassuming figure, that ever stood forth as an inspiration for all, whose voice was on the side of every movement tending toward the advancement of the colored people, who was a friend, ever in accord with Freedom, Property and Liberty, is hushed in the silence of the tomb, gone from the forest of life, his works are legacies for us to follow.

Fourth, That our sympathies go out to his afflicted relatives, deprived of his companionship and genial nature, and that copies of these resolutions be sent to his sorrowing relatives, to THE EASTERN REFLECTOR, Greenville, Pitt county, North Carolina, for publication, and be spread in memorial upon the records of this council sleep.

Strange Death of a Good Man.

While coming from his home to Greenville on last Thursday morning, Mr. J. C. C. Jenkins, of Contentment township met with a sudden death. He was riding on a buggy with two of his daughters, and when about a mile from town his horse took fright at a hand cart with which some colored children were playing in the road and ran away. All three of them were thrown from the buggy, a wheel running over one of the ladies, but apparently none were hurt. Mr. Jenkins got up and said he was not hurt at all and after stopping the horse began adjusting the harness. A gentleman riding a short distance behind came up and began conversing with Mr. Jenkins about the accident, and the latter had just remarked, "We ought to feel thankful that all of us escaped without injury," when he fell backwards to the ground, clenching his hands over his heart and began breathing heavily. In a few minutes he was dead. Mr. Jenkins has been troubled with heart disease for some years, and it is thought the excitement of the accident produced heart failure. Mr. Jenkins was among the oldest citizens of the county and a truly good man. He was held in the highest esteem by all who knew him and will be greatly missed. We extend our sympathy to his family.

Hon. Germain Bernard.

Death has again visited our town and removed one of our oldest and most respected citizens. Though for some years he has not been living among us, yet Hon. Germain Bernard's name is so intimately associated with Greenville that it is but just to claim him as one of her citizens. He had been in feeble health for a long while and had been residing with Mrs. McD. Boyd, his daughter, at Pilot Mountain. He had been in Greenville but a short while before his death. Mr. Bernard was born January 15th, 1820, and was the oldest native born citizen in Greenville. He was named for his grand-father, who came from Bordeaux, France, and settled in this State in Hyde county at Germantown, a place named in honor of him. Mr. Bernard attended school under the Elder Lovejoy, Horner, and Bingham. Afterward he took the course at Wake Forest College. From thence he went to Yale. After finishing his course at this College he studied law under Judge Pearson at Mocksville, and obtained his license from the Supreme Court to practice his profession.

While attending law school he met Miss Juliet L. Gillam, daughter of Wm. and T. H. Gillam, at Pilot Mountain to whom he was married in 1845. From this marriage five children were born. Two of these are dead. The three surviving ones, Mrs. McD. Boyd, Miss Mary N. Bernard, and Mr. C. M. Bernard, were with him at his death, which occurred at the home of his son, C. M. Bernard on Thursday, December 28th, at 3:30 o'clock, P. M.

While at Wake Forest he joined the Baptist church and was a liberal contributor to that church.

Mr. Bernard represented Pitt county in the House of Representatives in 1879 and in the Senate in 1881. He sleeps his last sleep by the side of his wife in the Baptist church yard who crossed the dark river before him on May 1st, 1884. The entire community sympathizes with the bereaved friends and relatives of one whom all had so long and so favorably known.

The burial services were conducted by Rev. G. F. Smith and the following acted as pall bearers: Hon. T. J. Jarvis, Cols. Harry Skinner and J. A. Sugg, Mess. J. J. Perkins, J. J. Cherry, G. B. King, F. G. James, E. A. Mow and C. D. Rountree.

Many friends were present at the burial to do homage to the lamented dead. Thus the old landmarks and honorable men of other days are passing away. Peace to their ashes.

LET US LOOK FOR SOMETHING BETTER.

The South has heretofore had the monopoly of the cotton production of the world, but the signs of the times indicate, that this will not continue to be the case. The experiments being made by Russia in growing cotton in Southern Siberia proves, that these immense plains of extremely fertile lands can produce cotton at a much less cost than it can be produced in the Southern States of America. We had as well look this matter squarely in the face and make up our minds for a continuance of low prices for this product. Cotton is no longer king, and the South can no longer rely upon cotton as the only market crop. In Egypt and India the growth of cotton is being rapidly increased and the Egyptian cotton is greatly superior to ours, and is largely imported into this country.

But what of this? The South is the finest country in the world and has more resources than any other section of the same area on top of the globe. We are not dependent upon any one product of the soil, and in this we differ with most other sections. It is the part of wisdom for the Southern farmers to look out for other crops and not exhaust all their energies on cotton and tobacco. Let us make first of all a plenty to eat. This is a matter of paramount importance. Without this there can be no prosperity in any agricultural community, and then, not ignoring cotton and tobacco, introduce other crops.

We called attention last week to the cultivation of the sugar beet. We believe there is an opening here for the profitable cultivation of this crop. That our soil and climate are highly suitable for the growth of the sugar beet admits of no doubt, but to make the matter certain, we suggest that the farmers of the country get together and select, say a half dozen practical farmers and make a thorough test of the matter the coming year. If the farmers will grow the beets in sufficient quantities, there are plenty of men with money who will be glad to establish a plant for the manufacture of sugar and pay cash for every beet delivered. In California and Nebraska the yield per acre is fifteen tons, for which the manufacturers pay \$75, and the cost of production is \$25 leaving a profit of \$50 per acre. We are satisfied that much less expense on account of the cheapness of our labor compared with labor in the West. Why not look into this matter? Let us show some enterprise and not move on in the same old rut rather than pull out on new land.

Why be satisfied to follow an old beaten track when we might get along better on a new one? That hop culture will pay in this section admits of no doubt, and at the expense at which they can be produced in this State, there would be a fine profit in their growth. We have been telling the people this for five years, and yet no one in this section has had the enterprise to make a thorough test of the matter. We know that for generations past our farmers have had a hop vine—one vine—not attended to, but allowed to run on the fence or on the ground, and yet our house-wives save from this vine enough hops for the use of the family for twelve months. Of course their cultivation will pay, and pay better than cotton and tobacco, or rather be profitable in conjunction with these crops.

The pecan is a valuable fruit which is purely a Southern growth. It thrives splendidly in this section and pays handsomely. Why not plant out the pecan and raise pecan orchards? Well, some one will say, we don't know anything about them or where to get them. That may be, but any man can find out who will try.

What we think would be a good thing, is for the farmers to have a convention and invite every farmer to attend and discuss these matters. Appoint committees to secure information and to make experiments. There would be something practical in this and we believe great good would result from it.—Warrenton Record.

The Overman Company has thrown a bomb-shell into the fort of high prices which will cause an awful scattering for cover on the part of the snail fry who have heretofore been waiting to see what the big guns intended doing. It looks as though the Victor next year again intended to "make the pace" as its makers have always claimed it to have done in the past.

DOGGING AN AVALANCHE.

A Hundred Feet Through Soft Snow Before a Threatening Slide.

While Mr. C. S. One towering pinnacle of snow, pushed a little beyond its fellows, seemed ready to totter to its fall. We looked at it doubtfully. It ought to have gone with the last avalanche. Would it stand, or would it fall within the next three minutes? A hundred feet is not much of a space to cross; but such crossing, if through fresh, broken snow from six to ten feet deep, is slow and floundering work.

From the time we came within view of the snow the utmost silence had been observed, and now, the searching but momentary scrutiny completed, Pingers whispered to us to come on. With noiseless speed we hurried forward. Silently we struggled through the snow, and as silently emerged on the farther side.

The attack was aimed at Foster, and Lucy Stone bade him flee for safety. "No," he said, "who will protect you?"

"This gentleman will protect me," she replied, putting her arm through that of the leader of the mob, who had just reached them. "Yes, I will," he responded, with energy, taking the girlish figure under his charge, and guiding her to a place of safety. Foster escaped with rough handling; the meeting was resumed, she made her speech, and a collection was finally taken up to replace the coat of the apostle, which had been torn from his body.—Harper's

HARDWOOD FLOORS.

Advantages Which They Present to the Housekeeper.

According to the Carpet and Upholstery Trade Review, the use of hardwood floors, with rugs as a substitute for carpets, is an idea which is rapidly winning favor in this country. Hardwood floors and rugs are superior to carpets from a sanitary point of view. They prevent the accumulation of dust and deposit of matter in the cracks and crevices of the under floor. The method of cleaning parquetry floors is also healthful. In the sweeping of carpets the dust is brushed through and into the fabric, or is carried into the air to be finally deposited upon every article in the room. But in cleaning the polished hardwood floor it is wiped over with a damp cloth, and it is, therefore, not necessary to do the amount of dusting which must always be done after a carpet has been swept.

A house provided with hardwood floors and with rugs for the colder months does not need the semi-annual cleaning with all its "terrors." It is cleanly and healthful at all times of the year.

These floors can be made ornamental and a part of the house decoration with the patterns properly chosen and of suitable woods to harmonize with the woodwork and furniture.

Yankee Bargains.

Land is not so dirt cheap in America now as it was when Lord Baltimore's company bought thousands of acres of fine ground for less than that number of glass beads, including the site of the city of Christiansburg, for which was paid one iron kettle of the bigness of five quarts or thereabouts."

Roger Williams bought Rhode Island for "forty fathoms of white beads, strung," and it is only about two hundred and fifty-five years since the site of New Haven, Ct., was bought for "twelve coats of English cloth, twelve spoons of mixed metal, twelve hoes, twelve hatchets, twelve porringers, twenty-four knives and some French knives and spoons." Probably the only business transaction on record that beat these, and is not American, was the purchase of Esau's birthright for a mess of porridge. And somebody has said that if Jacob had been an American he would have done better than he did. Instead of lavishly paying Esau "porridge down," he would have owed it to him.

Fortune Favored Them.

The entire product of the diamond mines at New Jagersfontein, South Africa, was taken during the first half of this year by a syndicate whose contract expired at midnight, June 30. Just before sundown on the last day of the contract the largest white diamond in the world was found. It is 3 inches long, from 1 1/2 to 2 1/2 inches thick and weighs 9714 carats, or 74 ounces avoirdupois. It is perfect in color, except for a black spot in the middle, which will probably make it advisable to cut it in two.
