Several weeks ago the Board of Aldermen appointed a committee consisting of Chief of the Fire Department, D. D. Overton, and Aldermen C. E. Rountree and A. B. Edington to receive bids and recommend some fire alarm system for Greenville, so last week these gentlemen reported that they were ready to submit bids from two concerns and Mayor James immediately ordered a call meeting of the Board for last night.
At this meeting it was decided to purchase the Gamewell fire alarm system, of Chicago, at a cost of about forty-three hundred dollars. The same to be installed not later than the 25th of next June.
There will be eighteen signal boxes in the city and a 10-inch steam chime whistle will be placed at the power house that will give the alarm and signal of what district the fire may occur.
The present whistle will very probably be retained, and be used for alarm during the nights, as its shrill is more powerful than the one that is to be installed.
The face of the alarm boxes are covered with a very small glass, which protects it from the pranks of the small boy, and when an alarm is sent in it necessitates the breaking of the glass, and immediately upon the pulling down of the lever it sounds the gongs at the station and electric plant, and the figures representing the box from which the alarm comes appears very conspicuously before the eyes of each station. This also connects with the chime whistle, giving the public generally the required information. If the alarm is phoned in to either of the stations the man in charge has a bell that gives the alarm and the district in which the fire occurs.
The fact that Greenville is to have a real sure-enough fire alarm system will, no doubt, meet the approval of all, as at present when the alarm is given there is no way to tell in what direction the fire is, and firemen as well as other citizens chase it backward and forward up and down the street asking the question "Where is the fire?"
When this installation is completed we will have a system of which we are well proud and one that will equal any of the small cities, or large, through Eastern Carolina.
When it comes to a necessity to advance any movement for the betterment of Greenville, our present Board of Aldermen exert every effort possible that the people may derive the benefit therefrom.

Edington to receive bids and recommend some fire alarm system for Greenville, so last week these gentlemen reported that they were ready to submit bids from two concerns and Mayor James immediately ordered a call meeting of the Board for last night.
At this meeting it was decided to purchase the Gamewell fire alarm system, of Chicago, at a cost of about forty-three hundred dollars. The same to be installed not later than the 25th of next June.
There will be eighteen signal boxes in the city and a 10-inch steam chime whistle will be placed at the power house that will give the alarm and signal of what district the fire may occur.
The present whistle will very probably be retained, and be used for alarm during the nights, as its shrill is more powerful than the one that is to be installed.
The face of the alarm boxes are covered with a very small glass, which protects it from the pranks of the small boy, and when an alarm is sent in it necessitates the breaking of the glass, and immediately upon the pulling down of the lever it sounds the gongs at the station and electric plant, and the figures representing the box from which the alarm comes appears very conspicuously before the eyes of each station. This also connects with the chime whistle, giving the public generally the required information. If the alarm is phoned in to either of the stations the man in charge has a bell that gives the alarm and the district in which the fire occurs.
The fact that Greenville is to have a real sure-enough fire alarm system will, no doubt, meet the approval of all, as at present when the alarm is given there is no way to tell in what direction the fire is, and firemen as well as other citizens chase it backward and forward up and down the street asking the question "Where is the fire?"
When this installation is completed we will have a system of which we are well proud and one that will equal any of the small cities, or large, through Eastern Carolina.
When it comes to a necessity to advance any movement for the betterment of Greenville, our present Board of Aldermen exert every effort possible that the people may derive the benefit therefrom.



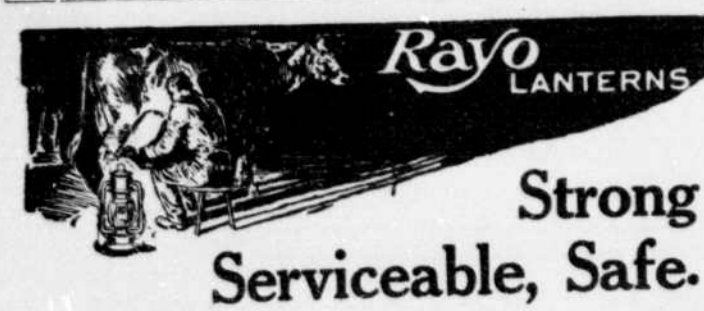

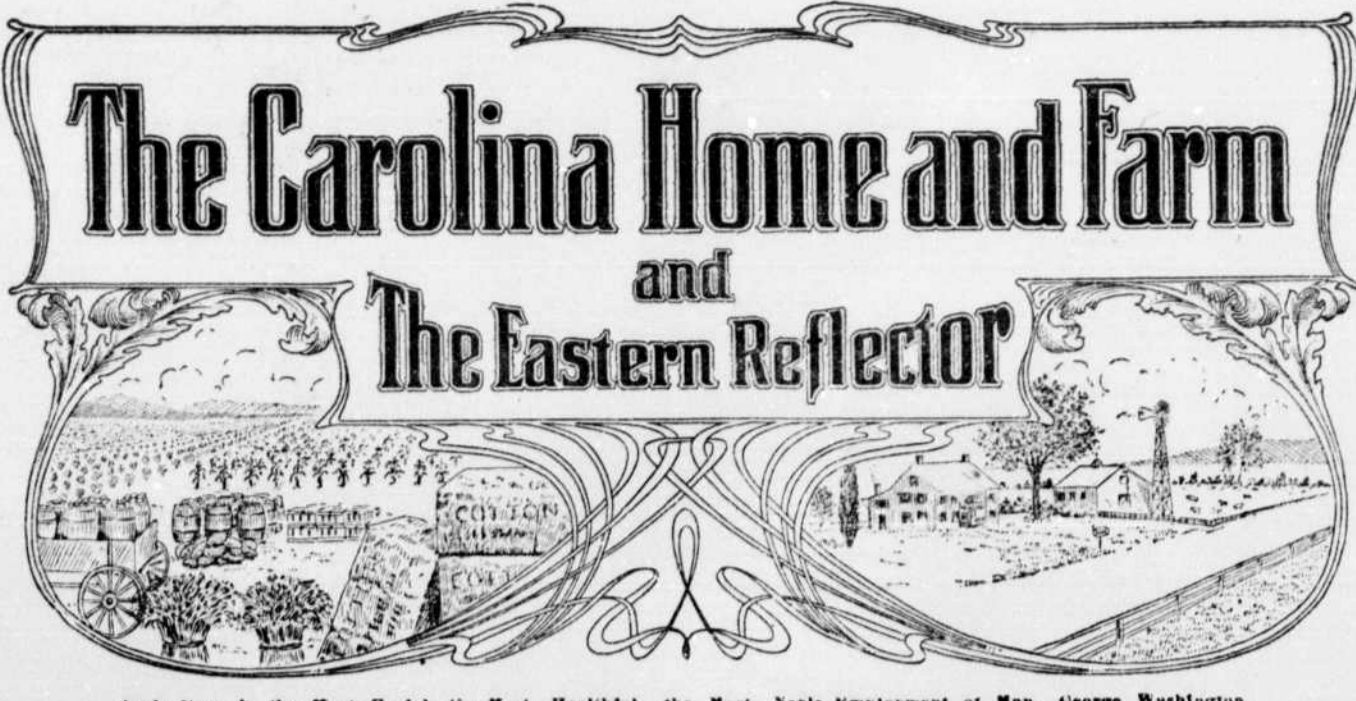

Under Death Sentence Gets New Trial. Officers Get Three Negroes At Big Mill.

OSHSING, N. Y., Feb. 24.—News that they were to die and that Becker was to have a new trial reached Gop of the Blood, Whiteley Lewis, Dago Frank Croliet and Lefty Louie Rosenberg in the death house almost at the same time that it reached New York.

ALBANY, N. Y., Feb. 24.—A new trial today was granted Charles Becker, the former New York police lieutenant, under death sentence for the murder of Herman Rosenthal, by the court of appeals.

NEW YORK, Feb. 24.—The crime for which Becker and the four gunmen received sentence of death stirred every stratum of New York society.

Herman Rosenthal a gambler, was shot down early on the morning of July 16, 1912, in front of the Hotel Metropole in the heart of the Tenderloin. He was sitting in the hotel cafe when a man told him he was wanted outside. He walked to the door and fell dead before a fusillade of pistol shots.

The police failed to trace the car until the clerk of the Elks' Club near by told them its number. The car was found, its owner and its chauffeur were arrested and other arrests followed rapidly.

The convictions of Becker and the gunmen were chiefly based on the testimony of Jack Rose, a gambler, "Bridget" Eber, Rose partner, and Harry Vallon, one of their agents. This trio turned state's evidence and Becker had hired the four gunmen to kill Rosenthal at Becker's request. Becker was a police lieutenant in charge of the "strong arm squad," whose duties were to keep in subjection gangs of the city and to regulate gambling places and houses of ill-fame.
