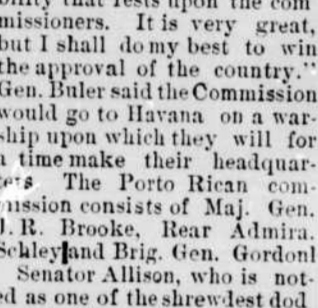
From our Washington Correspondent. Wash., D.C., Aug. 19, '98. Hurray for Admiral Dewey! He's the top-notch of the whole outfit.
