A Man's Unlucky Day
Probably the most wonderful story of a man's unlucky day that has ever been told appears in the Lancet, which introduces it as a curious instance of coincidence. When thirteen years old he fractured his left leg below the knee through falling from horseback, also on August 26. After this he did not work on August 26 for twenty-eight years, and, little wonder, but in the year 1890 he forgot his fatal day and went to work with the result that he sustained a compound fracture of the left leg. After this he has studiously avoided working on August 26, though never missing work at other times.
