### SUPERIOR COURT.

September Term in Session.

The following cases have been disposed of since last report:

The grand jury on Saturday afternoon made the following report to the court:

We the Grand Jury for the term beg leave to report; that we have acted on all bills coming before us and reported the same to the court; that we have no other bills to be acted on.

That we have visited the county home for the poor, and that we found the premises in an excellent condition. We called on the keepers' wife and asked permission to visit the room of each inmate, which was complied with and we proceeded to inspect each room and see each inmate. Of each we asked these questions: "Do you get plenty of food and clothing and have comfortable quarters?" To which all answered in affirmative, save two, and these two said "plenty such as it is."

But there are two inmates we wish to call attention to. One a girl about fourteen years of age, an idiot in deplorable condition. She is unable to walk or talk and must be kept in a chair tied during the day, she is in a room with a feeble woman not less than seventy years of age, and herself in a helpless condition, but conditions make it necessary for her to wait on this child, both night and day, such as putting her to bed and dressing her. The other is an insane girl confined in a room closed in with shutters and iron bars, in which she can not be comfortable during cold weather. We recommend that these two girls, inmates be arranged for in some other way. We are of opinion that Mr. Hardy deserves credit for the way the home is kept.

### Also, we have visited the convict camp and found it in good condition. The health of the prisoners is good. And we believe that the camp is properly ordered and kept.

We have visited the county jail and found that it is kept in splendid condition, and that the prisoners are well cared for. We have inspected the court house and found that the building needs some little attention in the way of repairs to the walls, floors, shutters, etc. Also, we recommend that a desk be bought for the clerk's office that his business may be more conveniently transacted to both the clerk and the public.

### ANOTHER TRAIN NEEDED.

Can Be Had With Proper United Effort

It has long been apparent that a daily train is needed on this branch of the Atlantic Coast Line, and THE REFLECTOR believes the time is now ripe to secure it if the proper effort is made. More than two years ago an effort was made to get another train on this road that for a time looked like would meet with success, but other things came along that sidetracked the movement for the time being. A Sunday train was put on, but this was of no practical benefit except for getting mail on Sundays and to give people who desired to do so an opportunity to travel on Sunday, yet this did not help the congestion of freight and the slow handling of passengers and mails on week days.

Then there was a makeshift of an evening connection with trains going west from Kinston that gave some relief to passengers and mail when the connection could be made. Now by a change of schedule on the Atlantic & North Carolina road this connection in the evening is practically broken, so that all dependance the one-time old branch of Coast line is on the rail train and on the train that is compelled to stop at the road. ### PITT COUNTY PUBLIC SCHOOLS

The scholars of the county are soon to begin another year's work. It may not be out of place to review briefly what has been accomplished during the past two years and make a few predictions as to the coming session.

Two years ago the board of education realized that the time had come to put a man in charge of the schools, giving all of his time to them. The progress made during these two years has shown the wisdom of their action. At this time there was not a public school in the county employing more than one teacher. Neither was there a single school tax district. Now there is a local tax district in Greenville employing a competent superintendent with seven additional teachers, with an enrollment of more than four hundred. At Bethel there is a school with a well equipped man as superintendent and four assistant teachers, with an enrollment of more than two hundred. At Ayden there is a graded school with a competent superintendent and four assistants, with an enrollment of more than two hundred. At Farmington the school has a splendid superintendent and three additional teachers, with an enrollment of two hundred or more. At Grifton there is also a good school with a splendid superintendent and three additional teachers, enrolling between one and two hundred. At Centerville two ladies are employed and the school enrolls about eighty pupils. At Ballant's X Roads the school employs two ladies and the enrollment last year was seventy eight.

All of these districts, except the last two, are local tax districts and more than \$12,000 of special taxes are paid. The teachers in all these schools are as thoroughly qualified for work, and are doing as good work, as any teachers in the state. The rural schools have shown almost an equal improvement. There were one hundred and five white teachers employed in the schools of the county last year, and only three of these held second grade certificates. Twenty five or thirty of the rural school buildings were newly painted last year, and in the past two years there have been built thirty new and commodious buildings.

In nearly all the districts the old desks, etc., are being replaced by comfortable ones. The school finances have been unusually well looked after. The last sheriff of the county, O. W. Harrington, was a fine collector and was always prompt in paying the school fund, having at all times an interest and pride in the development of this department of work in the county.

The appropriations for the present year will, we are informed, be fully as much, and there is a very fine month's term in every district. The enrollment and average attendance of the schools is increasing gradually all the time. The character of the work done is improving rapidly. The teachers are becoming better and better qualified to do up to date work. A live teachers' association is exerting a wonderful influence for the betterment of the schools.

### WINTERVILLE HIGH SCHOOL.

This is a latest structure containing thirteen bedrooms, parlor and dining room. This was filled when the next session opened and plans had to be laid for another dormitory. This known as the boys' dormitory, was built the next year and contained thirteen rooms. By this time the three buildings and equipment represented an outlay of about \$15,000.

During the scholastic year 1900-1901 the number of pupils enrolled reached 150, of which number 31 were boarders and six counties were represented.

The growth of this excellent school has indeed been remarkable and will continue. It is already the pride of Pitt county and the Neuse Association, and we see no reason why it should not become the educational center for all Eastern North Carolina. There is ample room for more buildings and equipment, and with the moral and Christian influences surrounding it we expect to see Winterville High school without a peer in North Carolina.

There is wisdom in concentrating money and teachers in one great school rather than dissipating both over a large territory with a number of schools. The very best advantages can be had in this way. The inmates made upon every boy and girl in a strong institution is entirely different from what it is in a weak one. Everything favors bringing enough boys and girls together to give them the very best advantages at the very least cost. This is what is looked for in Winterville High School. Its friends want to see the good work going on there enlarged and strengthened until it shall in every way meet the educational needs of the age.

### ACADEMY BUILDING.

1901-1902 the enrollment reached 218 the boarders being 51, with nine counties represented.

1902-1903 the enrollment reached 255 the boarders being 92, with eleven counties represented.

1903-1904 the enrollment reached 201, boarders 78, with thirteen counties represented.

1904-1905 the enrollment was 222, boarders 85, with eleven counties represented.

Two of these years arrangement was made for public school scholars of the district to be admitted which accounts for the enrollment being larger in those years.

The school has so grown in subject of this sketch. The Winterville High School located at Winterville, about six miles south of Greenville, is in our opinion one of the first institutions of its kind in North Carolina. With a board of trustees composed of the best men from a number of counties, with fine moral and religious surroundings, with an elegant Christian gentleman and scholar of marked ability at its head assisted by a competent corps of teachers, with splendid equipment, both in buildings and furnishings, it is preparing and sending out young men with character and education to take their places in life's work. Already its influence is being felt in all Eastern North Carolina and it is giving to the public this brief and inadequate account of its organization and progress.

The growth of Winterville High School since its foundation has been remarkable. The first beginning of the school was in the fall of 1890 when it opened with 22 pupils in a two room house that had been rented for that purpose. This was only a temporary arrangement until the permanent quarters for the school could be made ready. Prof. G. E. Lineberry and one other teacher constituted the faculty at that time.

A. G. Cox and Dr. B. T. Cox had donated a four acre lot and the citizens of the community joined in building the first house on the property. This was a well arranged two story building containing four recitation rooms, four smaller rooms for music and art and a large chapel. This was completed early in 1900 and at the meeting of Nouse Baptist Association in that year the building and grounds were donated to association to be equipped and become an associational school.

It was evident that early provision must be made for dormitories for the pupils, and in the following summer what is known as the girls' dormitory was built.

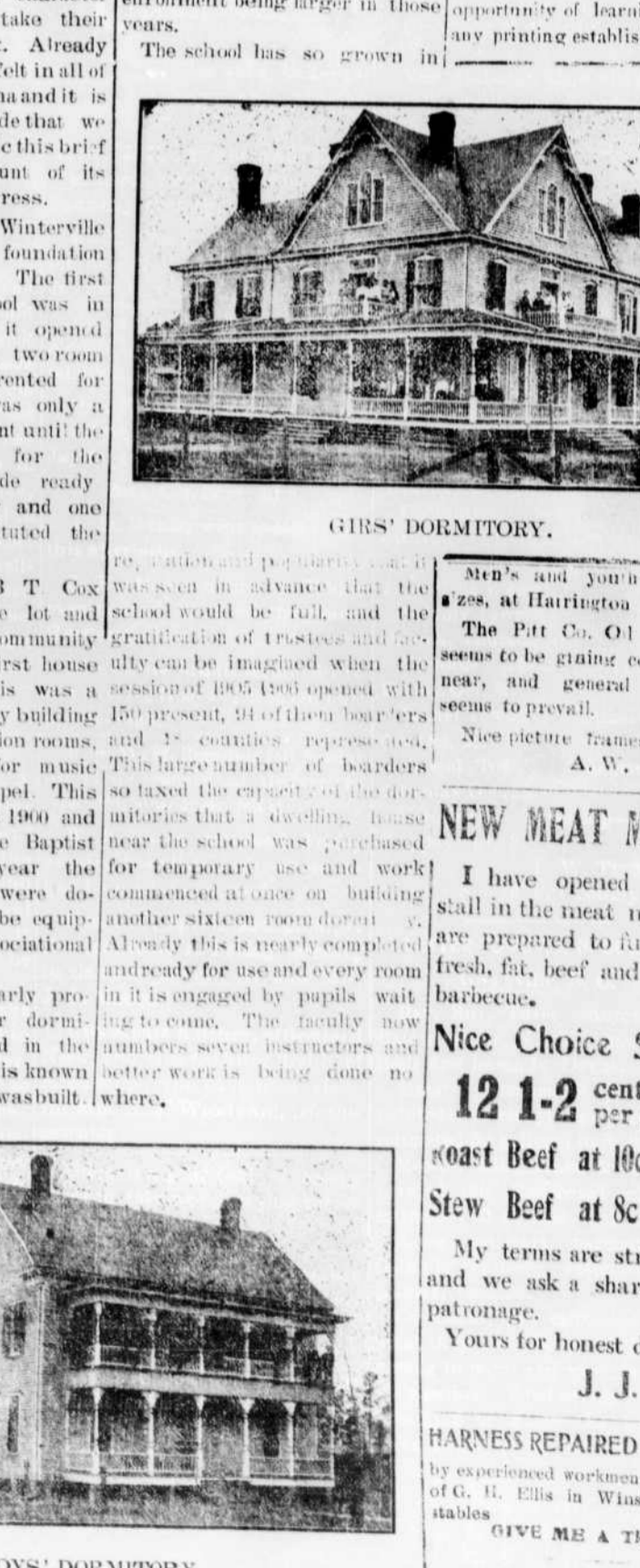
