Should my affiliation with The Veterans of Foreign Wars of the United States cease, in any way, I the Government of the United States of Amerwill consider this pledge as binding outside the Order ica recognizes that a state of war exists with as though I had remained a member of the same. All this I promise and pledge upon the honor of a true Comrade and a citizen of our great republic.
