- 1. If you have trouble receiving the Faculty Senate mailings, please inform the senate office.
- 2. Dr. Jenkins has informed the Faculty Senate that the Board of Trustees accepted its recommendation for the Optional Retirement Plan on February 15, 1972.
- 3. The University Curriculum Committee wants to remind you that its last meeting will be on May 4, 1972, however, anything to be brought to their attention must be in by April 27, 1972, when the agenda is prepared.
- 4. Senators should remind their departments that elections for the 1972-73 Faculty Senate should be completed prior to April 10, 1972, and that the Senate Office should be informed in writing no later than April 10, 1972.
- 5. Your senate has presented statements before two sub-committees of the Planning Committee of the Board of Governors. Senator Robert Woodside presented our statement concerning the role of the president in the 16 campus university before the Personnel Sub-Committee. We presented a statement concerning tenure, faculty participation in University governance, non-discrimination in hiring, and anti-nepotism rules that prevent qualified members of the same family from seeking employment with the university, to the Sub-Committee on the Code.
- 6. The Chairman of the Faculty participated with representatives from the old consolidated university campuses and other former regional universities in planning an organization to represent faculty interests before the new Board of Governors. An organizational meeting will be held in Greensboro on the North Carolina A & T campus on April 14 and 15, 1972. ECU will send four voting representatives to this meeting.

 - 1. The University Self-Study and evaluation by the National Council for the Accreditation of Teacher Education.

- 2. The University Provost responded to recommendation number two by advising that such action would be contrary to University policies regarding confidentiality of student records. The Committee withdrew its recommendation.
