2. Proposed change to the readmission and appeals procedure

A policy recommendation concerning this item is included in Section VI.

B. Items not Requiring Action of the Faculty Senate

1. Special admission procedure for talented students applying for music, art, and other programs including athletics.

Students applying for admission to East Carolina University who are deficient in math or foreign language and who have a special talent (music, art, athletics, etc.) may be admitted upon recommendation of the appropriate School Dean or Department Chairman. The student must remove the deficiency within one year from the date of his enrollment. Students deficient in both foreign language and math will not be considered.

2. Allowing transfer credit for the lowest passing grade

The Admissions Committee adopted the following resolution and sent it to the Committee on Credits:

Be it resolved that the Admissions Committee go on record as recommending that, if a transfer student meets all admission requirements, full credit be awarded for transfer courses on which the lowest passing grade was received and for which East Carolina University has equivalent courses to be effective with transfer students enrolling for the first time during the first summer session of 1972 and

thereafter.

 A proposal was submitted recommending that foreign language be deleted as an admission requirement at East Carolina University. No action was taken on this recommendation. A study is being conducted by the Admissions Office on an experimental group admitted to the fall term of 1967. One hundred seventyone students were admitted to this study group and were given two years to remove the language deficiency. A report on this study is expected within the next few months.

 New grading systems being used by colleges and universities throughout the country.

> Several nearby community and junior colleges changed, or are planning to change, to a "no failure" grading system. Several large universities, such as Yale, North Carolina State University, and others are considering changing to this procedure. The Admissions Committee is concerned about how to handle the mechanics of computing grade point averages plus many other procedures relating to this problem.

 A proposal to admit a limited number of well qualified seniors from the high schools of Pitt County and Greenville to one course each quarter for college credit.

> The Admissions Committee adopted a motion to accept a limited number of well qualified high school seniors from Pitt County and Greenville for a maximum of one course each term during the regular school year. The standards and testing procedures used to determine eligibility for the program will be developed by the Admissions Committee in consultation with the high school guidance counselor. This program will become effective on September 1, 1972.

VI. Policy recommendations to the Faculty Senate requiring a change to the Undergraduate Catalogue

1. Retention requirements for a second baccalaureate

The Admissions Committee recommends the adoption of the following policy concerning retention requirements for students seeking a second baccalaureate degree: SCHOLASTIC REQUIREMENTS FOR A SECOND UNDERGRADUATE DEGREE The student must maintain a grade point average of 2.0 or better. In determining the grade point average, only hours time of will be counted. Quality points earned in the first degree admission will not apply in determining scholastic eligibility while to a second enrolled for a second degree.

The student must also meet the curriculum requirements of the catalogue under which he enters for the second degree

or of some subsequent catalogue, provided that no student will be permitted to complete the second degree under a catalogue issued more than three years prior to the date of completion of the second degree.

The student must be enrolled in a regular program at East Carolina University for his last quarter of study.

A statement should be added to pages 91 and 94 of the Undergraduate Catalogue to implement this recommendation. If adopted, this policy will become effective on September 1, 1972.

2. Readmission and appeals

The Admissions Committee recommends the adoption of the following policy concerning readmission and appeals:

Students who have been out of school for at least one quarter must apply for readmission. Students who fall below minimum requirements to continue at East Carolina University and who wish to appeal to the Admissions Committee for readmission must present their appeals in writing no later than two calendar weeks prior to registration day. Students who have attended the second term of the summer session in order to qualify for the fall quarter must present their appeals no later than one calendar week prior to registration. No appeals will be accepted after these deadlines.

Generally in the past the Admissions Committee has not considered appeals from students in the following categories:

- 1. Those who after three quarters of University residence are down ten or more grade points.
- Those who after six quarters of residence are down fifteen or more grade points.
- Those who after nine or twelve quarters of residence are down twenty or more grade points.

The adoption of this policy will require a small change to page 91 of the Undergraduate Catalogue.
