RESOLUTION: Be it resolved that the University Calendar Committee submit to the Faculty Senate for its consideration at the next meeting of the Faculty Senate an "early semester" academic schedule, in general conformity with the other constituent institutions of the University of North Carolina, for the academic year, 1975-1976, and subsequent years thereafter.

A proposed special calendar for Summer 1974 was presented to the Faculty Senate and approved Nov. 13. This calendar provided for one 8 week session and two sessions in addition to the two regular sessions. A proposed calendar for 1974-75 was presented to the Faculty Senate on Dec. 11, 1973 and approved.

V. Several questions were considered by the committee during the year. Primarily the summer calendar for 1974 and the regular 1974-75 calendar were developed. Extensive and repeated meetings were held in an attempt to hear all interested individuals and to apply their suggestions to the 1974 summer calendar. The committee extensively revised the summer calendar to provide two mini sessions and one extended session in addition to the two 'regular" summer sessions. These innovations will have to be evaluated by next year's committee to determine the relative merit of the calendar.

The committee discussed the fact that a "better" calendar within the present quarter system might allow improved interaction with other educational institutions; more realistic divisions of class time relative to the usual vacations; more efficient use of faculty and facilities; and more opportunities for the student with respect to travel and entertainment within the vacation schedule.

The calendar for 1974-75 was developed to assure equal numbers of class days and equivalency in the exam schedule. Several variations of the quarter system were considered but the 1974-75 calendar remains "traditional." A drafted calendar for the 1975-76 school year, involving an early quarter system was proposed. A faculty-wide vote held on the proposed calendar indicated that a "regular" quarter system was preferred. The vote indicated 117 FOR, and 206 AGAINST the proposed early quarter system. However, it was apparent from comments received that many individuals did not understand the proposed calendar. The committee deferred further action pending Faculty Senate consideration of a complete reorganization of E.C.U.'s calendar system. The committee has been told that the Senate may wish to consider a semester system.

- VI. Recommendations
 - A. The Committee recommends that the Senate postpone any decision relative to the adoption (or non-adoption) of the semester system until the Fall Quarter 1974 in keeping with the general agreement made before the referendum conducted in the Fall of 1971. The agreement simply stated that the question of semester system vs. quarter system would not be brought up again for three years. The Committee realizes that this was a non-binding, unwritten agreement but never the less, urges the Senate to abide by it.
 - B. The Committee recommends that the Faculty Senate, before taking any action on quarter versus a semester system, direct the Chairman of the Faculty to appoint an Ad Hoc Committee to conduct a referendum on the question of semester vs. quarter systems. The Committee recommends that if such a referendum is conducted, that the General Faculty simply be asked to vote for either the quarter system or the semester system. The Committee believes the precedent of submitting this question to the General Faculty was established by the Senate in 1971 and should be followed again before any change is contemplated. The Committee also recognizes that such a referendum is non-binding on the Senate.
- VII. Response to the committee's recommendation:

 The Faculty Senate as well as the general faculty have been quite responsive to the committee's requests for opinions and/or varification of action. The committee has been pleased at the response of the faculty to requests for their opinions as to the calendar structure. The committee recommends that all faculty members make their opinions known to the committee.
