

CHANGE IN BY-LAWS

On page 120 of the 1973-75 Faculty Manual under By-Laws East Carolina University Faculty Senate, add the following By-law change:

V. "The immediate past chairman of the faculty shall serve as an <u>ex-officio</u> member of the Agenda Committee, the Governance Committee and the Committee on Committees."

GOVERNANCE COMMITTEE

The Governance Committee recommends the following change to the By-Laws of the Constitution of the Faculty Senate:

By-Law I, 2. Only elected and <u>ex-officio</u> members (including alternates, <u>if</u> representing their Units) may answer the roll call, vote, or occupy seats assigned to Senators.

The portion in parentheses is new.

COMMITTEE ON COMMITTEES

The Committee on Committees recommends the following amendment to the charge of the Course Drop Appeals Committee:

"Committee members are to be elected for staggered 2 year terms," rather than the present 3 year term.

CHARGE OF AD HOC SCREENING COMMITTEE

Change in the charge of the Ad Hoc Screening Committee for Codes of Operation (See Faculty Senate Agenda for February 20, 1973) from:

"Limits: Within thirteen (13) months of the adoption of the ECU Code, . . ." to:

"Limits: Within twenty (20) months of the adoption of the ECU Code, . . . "

RESOLUTION TO CHANCELLOR JENKINS

WHEREAS the current inflation has hurt the low income person more than others, and WHEREAS the salary inequities are more prevalent among the low income faculty members

Let it be resolved that if the University receives a 5% salary increment, that the <u>average</u> raise for those whose salary is over \$20,000 be 2%, that the average raise for those whose salary is between \$15,000 and \$20,000 be 4% and the remainder of the money be used to increase the salaries of those making less than \$15,000.
