

WHEREAS, only a small amount of funds has been appropriated for faculty and staff salary increases for 1975-76; and WHEREAS, there appears to be little hope for a substantial salary increase for 1976-77;

THEREFORE, LET IT BE RESOLVED that the Faculty Senate requests the Board of

Trustees to reconsider its ruling that faculty and staff must pay tuition if

more than one course per quarter is taken.

The Faculty Senate believes that the deletion of a fringe benefit at the very time faculty and staff are being asked to cope with inflation with no salary increases is an affront to the faculty and staff and that such action will have a negative influence on morale which will far outweigh the monetary gain to the University.


CHANGE IN FACULTY MANUAL


On page 70 of the 1973-75 Faculty Manual in the first paragraph, delete "on tenure"

and add "permanently tenured or untenured."

CAN THE WAY

The first paragraph would then read: "Leaves of absence for one or more quarters without salary may be arranged with faculty members, permanently tenured or untenured, for the purpose of advanced study, research, or public service without prejudice to future promotions in rank, provided the period of absence is reasonable and does not work undue hardship upon the University."
