Pre-registration for Summer Session and Fall Quarter

The Summer Session consists of two terms of 5½ weeks each. Three hour courses meet 60 minutes and five hour courses meet 100 minutes. There are no Saturday classes. In order to accommodate certain students, various Departments will wish to offer some shorter courses in a mini-term. It is recommended that four week courses originate on Monday, June 14th, in the first term and on the same Registration day (July 14th) in the second term, whenever possible. Final examinations will be given on the last regularly scheduled class day.

Graduate students expecting to begin work in the summer must complete application at least two weeks before registration.

A student may not enter a course later than the third meeting of a Summer Session class and receive credit. During the first ten days, an undergraduate student may withdraw or drop a course without receiving grades for courses for which he is enrolled. After the first ten days, an undergraduate student withdrawing from school shall receive a grade of F for all classes which he is failing at that time unless, in the judgment of the Provost, Vice Chancellor for Health Affairs, or Dean of Continuing Education, as appropriate, the failures were caused by circumstances beyond the student's control. After this time, an undergraduate student may drop a course only due to unforeseeable and uncontrollable circumstances and only with the permission of the Provost, Vice Chancellor for Health Affairs or Dean of Continuing Education.

Applications for graduation in a given term must also be made within the three day entrance period.
