2. Athletic Grants-in-Aid were approved during the year as presented.
See attached summary.

3. The Ruth Fowler Moore Scholarship was announced.
4. An inventory of scholarship and Financial Aid funds were made.
5. Subcommittee wrote proposal for acquiring funds for use as unrestricted scholarships for recruitment of outstanding students to ECU.
6. Five new scholarships of \$100.00 each were announced by the Department of Drama and Speech in the areas of performance, technical theatre, designing for the theatre, costuming and broadcasting.
7. Committee decided to terminate the out of state "Illinois Junior Academy of Science" program with East Carolina University.
8. Committee rejected to include the East Carolina University in the Society of Distinguished American High School Scholars.
9. Committee assisted the League of Scholars in recruitment of scholars.
10. Committee approved the subcommittee report on resource development.
11. Committee discussed the introduction of a surcharge on all athletic and other entertainment tickets for unrestricted scholarship funds.

- VI. The committee made the following recommendations to next year's committee.
- a) Next year the Scholarship Committee should check with Chancellor Brewer about soliciting new scholarship funds.
 - b) Review catalog material related to scholarship and financial aid.
 - c) Committee should act on the report of the subcommittee on procedures.

- VII. The committee is evaluating its structures, duties, functioning, and personnel, considered itself a sound body serving a need of the campus community.

The primary duties of the committee are:

1. To adopt policies and procedures by which the various financial aid programs are administered.
2. Contact and interview the East Carolina University sponsored National Merit scholars.
3. To hear grievances pertaining to financial aid and to arrive at a conclusion.
4. To review and approve Athletic Grants-in-Aid and other applications submitted to the committee by the Financial Aid office.
5. The committee is capable of functioning during the summer as well as during the academic year. Members of the committee are conscientious and attendance is very good at the business and interview sessions.
