V. Questions Discussed by the Committee During the Year

1. It was announced in late summer that there would be no increased funding for the Computing Center during the Fiscal Year, 1977-78. Dr. Joyce consulted with Vice-Chancellor Howell and reported on the fiscal situation.
2. A proposal from Burroughs Corporation to upgrade our computer system within our present budget was received. After much study the Committee (the UCC) recommended that this proposal be accepted. State purchasing refused to sole-source the procurement. It was then decided to go out on open bids. The committee helped draft the specifications and confirmed that faculty interest was represented in the process. Award of a contract will probably not take place until after Spring semester.
3. The UCC recommended to the Committee on Committees that the Curriculum Committee forward all course or curriculum proposals that require central computer resources to the UCC for its consideration. A resolution of the Committee on Committees and the Faculty Senate requiring the UCC to advise the Curriculum Committee on new courses requiring central computer facilities was vetoed by Chancellor Jenkins.
4. A questionnaire soliciting information for the Faculty Expertise Directory has been sent to all faculty. This directory will be used by User Services and faculty members to find expertise in various specific computer-related areas.
5. The UCC recommended a Code of Ethics for computer users to Mr. Lennon.
6. The question of better communication between faculty making computer assignments and User Services was discussed.
7. The UCC discussed "game-playing" on the computer and recommended that nonclass-related game-playing on the computer during the last three weeks of a semester be considered a violation of the Code of Ethics.
8. The subject of controlled computer growth was discussed and referred to the Planning Subcommittee.
9. A number of routine procurement requests and other matters were considered and recommendations made.

VI. Policy Recommendations Made by Committee

1. The UCC recommended to the Computer Policy Committee that the Burroughs Upgrade Proposal be accepted.

2. After the inability to sole-source the computer upgrade the UCC recommended an open bid procurement document.
3. The UCC recommended a Code of Ethics for computer users to Mr. Lennon.
4. The UCC recommended to the Committee on Committees that the Curriculum Committee forward all course or curriculum proposals that require central computer resources to the UCC for its consideration.

VII. Response to the Committee's Recommendations by Appropriate Agencies

1. The Computer Policy Committee pursued the Burroughs Upgrade Proposal.
2. The Computer Policy Committee is pursuing open-bid procurement.
3. Mr. Lennon has accepted the Code of Ethics.
4. The Committee on Committees sent a similar resolution to the Faculty Senate and thence to the Chancellor where it was vetoed.

NOTE: The recommendation in last year's annual report to the Computer Policy Committee concerning admendments to Computer Policy Numbers One and Two has been accepted by the Computer Policy Committee.
