- X. Evaluation of the committee
- A. Structure. The structure of the Committee is satisfactory; however, the relationship of the Committee to the University is unclear.
 - B. Duties. The charge of the Committee is far greater than the authority of the Committee. The Committee feels it has moved in a positive direction.
 - C. Functions. Resolutions were appropriately presented to the Faculty Senate.
 - D. Personnel. Outstanding! Committee meeting attendance was improved, resignations were non-existent, and members even volunteered for committee work. Poor student attendance was noted.


