After submitting the petition to the chairperson of the Faculty Affairs Committee, the petitioner is invited to present orally the grievance before the entire committee. Following the presentation, the Committee decides whether the grievance falls within its authority, whether the petitioner has exhausted appropriate channels, and whether the grievance merits a detailed investigation. If the

case is accepted, the chairperson will appoint a subcommittee to investigate the case and then report back to the full committee. The full committee then decides what further action is warranted.

 - A. Subcommittees were appointed to investigate the following grievance cases:
 - 1. A member of the Department of Industrial and Technical Education charged salary discrimination. The Library Committee adequately represents the entire University.

The committee and its subcommittees have transcended vested (i.e., Unit) interests in helping to determine Library policies that are fair to the entire University community. It has an amiable relationship with the Joyner administration and staff and, through this constructive relationship, has been able to base its policy decisions on professional research conducted by the librarians.

VII. Committee Accomplishments Including Recommendations Made to Agencies Other Than the Faculty Senate:

In response to the directive of the Faculty Senate on 24 April 1979 to add a research factor to the 'modified' Colorado Plan for serials and monographs, the committee appointed a subcommittee to develop such a factor. After a subcommittee meeting with Vice Chancellor Maier, the committee decided to work with the Academic Subcommission in gathering the necessary data. The committee accepted the subcommittee's recommendation that the definition of research and creative activity include publications, papers, performances, grants, and exhibitions and further that an "adjustable index" for each unit be developed that reflects such activity.

Due to the late deadlines of the Academic Subcommission, it appears that this work will not be finished this year.

Another significant activity of the committee and its Handbook Subcommittee was the development of a Committee Handbook containing committee procedures, committee and library policies. It is expected that this will be a major reference source for committee members now and in the future.

The committee has begun a series of library staff presentations on the various technical operations of the library. Written reports of these presentations will be made to the Faculty Senate to ensure widespread distribution of the information.

The committee considered a revised charge submitted by the Committee on Committees. A revision of this charge was returned to the Committee on Committees. The committee received input from Director JoAnn Bell, Deans Perry and Thiele, and Associate Vice Chancellor McDaniels. (All concerned administrators were invited to be involved in this process.)

The Committee considered three additional topics: (1) Coordination of Curriculum Development and Library Resources, (2) Coordination of Faculty Personnel Policies and Library Resources, and (3) Coordination of General University Expenditures and Library Expenditures. On the latter two topics the committee, after much discussion, felt that everything that could be done was being done at this time. The first topic is still under consideration.

In the fall of 1979, a new top level computer committee was formed the Information Systems Advisory Committee to consist of the four Vice Chancellors, the Chairman of the UCC, the Chairman of the Administrative Computer Users Committee, and when formed, the Chairman of the medical school committee. On December 12, 1979, the UCC recommended that its charge be changed so that "The chairman of the UCC shall represent faculty interests as a member of the ISAC."

VII. The UCC spent several meetings and had special discussions with both Vice Chancellor Maier and Vice Chancellor Lemish concerning the new ISAC computer committee and whether the UCC could commit its support to this committee without jeopardizing academic interests. It was finally decided to alter the charge of the UCC so that the UCC Chairman could sit as a member of the ISAC and communicate faculty interests to that committee. The UCC Chairman has attended five of these ISAC meetings and has been encouraged by the positive attitude evinced there. The chairman has also presented the following three UCC resolutions to ISAC on March 28, 1980: 1. What is the official University policy for using computer time as part of University matching funds for grant proposals? 2. Whereas the Computer Planning Task Force Report to the Chancellor recommends that there be an Office of Academic Computing, and Whereas the University Computer Committee feels that faculty presence in such an office is important, Therefore, the University Computer Committee recommends that the nucleus of a future Office of Academic Computing be established through the use of released time to create at least one position for assisting academic users. 3. Whereas, academic planning and student advisory needs for information would be best met from one source, and Whereas, proliferation of an unwieldly and inefficient administrative data base would have an adverse impact on service to the academic community, Therefore, a real immediate need is perceived for the position of Data Base Administrator.
