1. Calendar Committee
2. Five (5) faculty members and one student member, plus ex officio: Vice Chancellor for Academic Affairs or an appointed representative
3. Three (3) elected faculty members
4. A. The Calendar Comittee is concerned with (1) the number of days the University shall be in session during the regular terms and the beginning and closing dates; (2) the number of days and the beginning and closing dates for each semester and summer session term; (3) the scheduling of examination periods; and (4) the scheduling of holidays and vacation periods. The Comititee shall make recommendations concerning these matters.
B. The Committee makes its recommendations to the Faculty Senate in time for revision or amendment by the Faculty Senate.
C. The Committee reports to the Faculty Senate as often as necessary, but at least once a year.

October 15, 1980
Revised Charge of:

1. Continuing Education Committee
2. S faculty members and 1 student member, plus ex officio: Vice Chancellor for Academic Affairs or an appointed representative, Dean of the Division of Continuing Education, and Director of the Counseling Center or an appointed representative.
3. Quorum: 3 faculty members exclusive of ex officio.
4. A. The Continuing Education Committee advises the Dean of Continuing Education on programs, faculty, student services such as study skills, career and academic counseling, and future directions of continuing education. The comittee examines and recomends policies relating to faculty teaching including qualifications, number of hours and compensation, in the Division of Continuing Education.
B. The comittee recommends to the Faculty Senate policies relating to teaching assignments, qualifications, and compensation of faculcy
ith in the Division of Continuing Education. The committee makes appropriate recommendations to the Dean of Continuing Educarion.
C. The committee reports to the Senate as often as necessary but at least once a year.
D. The committee is empowered to recommend to the Dean of Continuing Education prograns relating to the Division of Continuing Education.

October 15, 1980 Revised Charge of

1. Faculty Governance Committee
2. Seven faculty members, plus ex offlcio: Vice Chancellor for Academic Affairs or an appointed representative and the imnediate past chairman of the Faculty in residence.
3. Quorum: Pive faculty members exclusive of ex officio.
4. A. The Faculty Governance Commttee considers matters relating to the Constitution and By-Laws of the Faculty Senate; the Faculty Manual, where there is no conflict with the functions of the Comiftee on Comnittees, unit codes of operation; unit reevaluations, and the East Carolina University Code. The Committee insures that unit codes continue to conform to the East Carolina University Code, all additions and deletions to both the university and academic unit codes to be submitted to the Cominttee, for its review, before submission to the Faculty Senate, and hears appeals by any faculty member concerning the application of governance procedures of both the university code and the unit code within his or her unit.
B. The Committee recommends changes in the Constitution and By-Laws of the Faculty Senate, the Faculty Manual, the East Carolina University Code and the unit codes to the Faculty Senate. Then evaluating the implementation of governance procedures, the Committee makes recomendations to the unit and to appropriate administrative officials.
C. The Conmittee reports to the Faculty Senate as often as necessary, but at least once a year.
D. As an appellate body, the Committee is empowered to evaluate the manner in which govemance procedures have been followed and to make this evaluation known to the appropriate adninistrative officials and faculty.
