FACULTY SENATE OF EAST CAROLINA UNIVERSITY ORGANIZATIONAL MEETING OF 1981/82 ACADEMIC YEAR

The Organizational meeting of the Faculty Senate for 1981/82 was called to order by Chair Thomas Johnson on Wednesday, April 22, 1981, at 2:10 p.m. in Room 221, Mendenhall Student Center. The Secretary noted the following members were absent: Muzzarelli (Allied Health), McGee (Continuing Education), Haskins (Drama), Brinn and Cheng and Mozley (Medicine). Alternates present were: Somes for Lao (Allied Health), Bellis for Allen (Biology), Neal for Spruill (Geology) and Duff for Settle (Home Economics).
