

UNIVERSITY CURRICULUM COMMITTEE

MINUTES

November 30, 1981

The University Curriculum Committee met on November 30, 1981, in Brewster B-103 at 3:00 p.m. Members present: Grossnickle, Boyce, Broadhurst, Cain, Daugherty, Hancock, Holt, Moore, Leahy, O'Rear, and Topper. Members absent: Chancellor Brewer and Johnson (ex officio).

The Chair noted that the crosslisting of HSEM 2070, Psychology, would change both the BA Major and the BA/BS minors in Psychology. This was deleted from the previous minutes of November 23, 1981.

Professor Louis Zincone, School of Business, presented the new course proposal, DSCI 3243, Managerial Economics. Professor Daugherty moved to accept the course, Moore seconded, and the motion passed.

Professor John Maiolo, Department of Sociology and Anthropology, presented a new course proposal, ECON 3243, Intermediate Microeconomics. In the proposal, item III, A.2. This course is required in the above minor. Professor Boyce moved to accept the proposal, Hancock seconded, and the motion passed.

Professor T. Yarbrough, Department of Political Science, requested that POLS 2104, Civil Liberties, be changed to POLS 3224. Professor Cain moved to accept the new course proposal. Boyce seconded, and the motion passed.

Professor Donald Collins, Department of Library Science, presented LIBS 3102, Research Sources and Techniques. Professor Boyce moved approval, Daugherty seconded and the motion passed.

Professor O'Rear presented a number of requests from the Department of Biology. BIOL 2120, Human Physiology and Anatomy, changed to BIOL 2130, Survey of Human Physiology and Anatomy. This change affects the 1981-82 Undergraduate Catalogue on the following pages: 180, 181, 274, 275, 276, 355 and 403. BIOL 2121, Human Physiology and Anatomy Laboratory was requested to be changed to BIOL 2131, Survey of Human Physiology and Anatomy Laboratory. Two new course proposals were presented, BIOL 2140, 2150, Human Physiology and Anatomy; BIOL 2141, 2151 Human Physiology and Anatomy Laboratory. The course proposal for BIOL 2140, item I.E. should read, "prerequisite for BIOL 2150". The course proposal for BIOL 2141 for item I.E. should read: "prerequisite for BIOL 2151". Professor Holt moved to accept the changes, Broadhurst seconded, and the motion passed.

Professors Martin Schwarz and Luis Acevez, Department of Foreign Languages and Literature, presented the following proposals: A change in level for French, German, and Spanish 2005 to FREN 3005, GERM 3005, and SPAN 3005. They presented a new course proposal for LATIN 2221, Latin and Greek in Current English Usage. Professor Grossnickle moved to accept the request that FREN, GERM, SPAN 2005 be raised to FREN, GERM, SPAN 3005. Broadhurst seconded, and the motion passed.

Professor Cain moved to accept the new course proposal LATIN 2221, adding, "...satisfy a language and literature requirement." in item I.F. of the course proposal. Boyce seconded and the motion passed.

Professor E. Perry, School of Nursing, presented the revised proposal for the B.S. in Nursing degree which includes changes in CHEM requirements, deletion of BIOL 2120, 2121; BIOL 2140, 2141, 2150, 2151 added as degree requirements; and the minimum degree requirements increased from 128 s.h. to 131 s.h. The discussion and vote of the Committee was held in abeyance until a representation of Chemistry arrived.

Professor Robert Holt, Department of Philosophy, presented a number of changes in the PHIL curriculum. Course numbers changed PHIL 2310 to 3310; 2330 to 3330; 5250 to 4250; 5260 to 4260; 5271 to 4271. These course numbers and title changes as follows: PHIL 2320 to PHIL 3320, Medieval and Renaissance Philosophy; PHIL 2340 to PHIL 3340, Twentieth Century Analytic Philosophy; PHIL 3452 to PHIL 3453, Existentialism/Phenomenology; PHIL 5281, to PHIL 5283, Philosophy of Language. The requirements for the major in Philosophy requested to be changed:

Requirements in Philosophy: 33 semester hours as follows:

- A. 3 s.h. from 1500, 3580.
- B. 9 s.h. from 3310, 3320, 3330, 3340, 3453.
- C. 3 s.h. from 4250, 4260, 4271, 5272, 5283.
- D. Electives: 18 s.h., of which 6 s.h. must be above 2999, exclusive of courses in religion (PHIL 1691, 1692, 2490) which cannot be used to satisfy major requirements in Philosophy although they may be used by Philosophy majors to satisfy General Education humanities requirements. The Department encourages majors to enroll in upper division courses as electives whenever possible..... 33 s.h.

The Committee noted that in the European Studies Minor Program, PHIL 4333, has been banked. Professor Boyce moved to accept the requests, Daugherty seconded, and the motion passed.

Professor Carol Collins, Department of Mathematics, requested changes in the catalogue descriptions and degree requirements:

3. Change PROFICIENCY REQUIREMENTS to read: "Before a student is permitted to officially elect mathematics or computer science as a major, he or she must earn at least a C on all mathematics and computer science courses taken below the 3000 level." (Page 210)

Remove sentence in parentheses at end of course description which reads: "(Cannot be used for any degree program, major or minor, in mathematics.)" (Page 219)

Professor Daugherty moved to accept the changes, Boyce seconded and the motion passed.

Professors W. Hankins and M. Wubneh, Department of Geography and Planning, presented proposed changes for the B.S. major and B.A. minor in Urban and Regional Planning, adding a B.S. minor, and other changes in the curriculum. New course proposals were presented as follows: PLAN 3000, Urban Planning; PLAN 3001, Planning Techniques I; PLAN 3010, Regional Planning; PLAN 3011, Planning Techniques II; PLAN 3012 Planning Legislation; PLAN 4025, Housing and Neighborhood Planning; PLAN 4076, Site Design Studio; PLAN 5005, Land Use Planning; PLAN 5006, Land Use Planning Studio (5005 and 5006 course proposal, Item I.E. listing as co-requisites); PLAN 5015, Transportation Planning; PLAN 5016, Transportation Planning Studio, (5015, 5016 course proposal, item I.E. listing as co-requisites). PLAN 5025, Coastal Areas Planning and Management (delete PLAN 5020) item I. D. 5 contact hours per week; PLAN 5045, Environment Resources Planning and Management; PLAN 5055, Soils and Planning; PLAN 5111, 5121, 5131, Problems in Planning. The proposed curriculum for the B.S. degree in Urban and Regional Planning (see attachment) was presented. Professor Hancock moved to accept the proposals as amended, Leahy seconded and the motion passed.

Professors Fred Ragan and W. Calhoun, Department of History, presented a proposed track in the B.S. degree program and a new course proposal, HIST 4940, Internship in Public History. The Committee voted to return the proposal to the Department for reconsideration.

Professors W. Hankins and M. Wubneh, Department of Geography, presented GEOG 2010, Introduction to Soils, and GEOG 2011, Introduction to Soils Laboratory. Professor Boyce moved to accept the new courses, Moore seconded and the motion passed.

Professors E. Zallen, V. Rosenfeld, J. Shea, and G. Yadav, School of Home Economics, presented various changes in the Home Economics curriculum. On page 355, Undergraduate Catalogue, Food, Nutrition..., add to Plan IV requirements, HOME 5303, 5304, Experimental Foods, and choice of 5321 or 5335, Delete HOME 2126 from Coordinated Undergraduate Program. Delete as an option for Plan IV, Home 2180, 2181, Interiors. Change course number (page 362) from HOME 5357 to HOME 4357.
