Since the committee is now made up of six members, all serving two-year terms, three to expire in 1983, three to expire in 1984, the following arrangement will be observed to insure staggered three-year terms in the future:

- 1) of the three members whose term of office expire in 1983, the term of one member will be extended one year,
  - 2) of the three members whose term of office expires in 1984, the term of two members will be extended one year,
  - 3) the members who will have their term of office extended will be determined by the Course Drop Appeals Committee by majority vote, and reported to the Committee on Committees by March 4, 1983.

RESOLVED, that the Faculty Senate recommend to the Chancellor that determination of merit raises, when not available annually, be based on the "degree of teaching excellence, creative activity and research, and service" accomplished during the total period elapsing since the last merit raises were available.
