The Faculty Governance Committee recommends adoption of the following proposed amendment to "Appendix D." The purpose of this amendment is to guarantee to faculty those procedures pertaining to personnel decisions that are contained within the various university codes and appendices. The Governance Committee suggests that this recommendation be given two readings before the Senate with final action being deferred until the second reading.

The Faculty Governance Committee recommends that Section IV of "Appendix D" of the 1985 edition of the Faculty Manual <see pp. D 9 - D 10) be amended as follows:
(1) p. D-9, under "A. Conference with Departmental Chairperson, fourth line, following the word "was," insert the words: "affected by a material procedural irregularity (see C. below) or was"...
(2) Under C., P. D-10, second paragraph, third line, following the word "was," insert the words: "affected by a material procedural irregularity or was"....
(3) Under C., p. D-10, at the end of the second paragraph, add: "Whether a material procedural irregularity occurred shall be determined by reference to those procedures which were in effect when the Chancellor's decision not to reappoint was made and communicated to the affected faculty member. The Hearing Committee shall ask the Chancellor to certify what procedures were in effect if this be a matter of dispute. For purposes of this Section IV, 'material procedural irregularity' means a departure from prescribed procedures governing reappointment that casts reasonable doubt upon the validity of the decision not to reappoint.
(4) Under C., P. D-10, third paragraph, third sentence, following the word "was," insert the words: "affected by a material procedural irregularity or was"....
(5) Under C., P. D-10, fourth paragraph, third sentence, following the word "was," insert the words: "affected by a material procedural irregularity or was"....

The Faculty Welfare Committee recommends to the Faculty Senate that, in addition to the Faculty Data approved by the Senate on October 21, 1986, the following data be included for each chair each year to be used in making salary recommendations.

Prepare a multiple linear regression on faculty salaries to determine predicted salaries using the following variables:
A) Sex ( $0=$ Male, $1=$ Female)
B) Degree ( $0=$ Non-Degree, $1=$ Doctorate)
C) Rank (1=Professor, 2=Associate Professor, 3=Assistant Professor, $4=$ Instructor, and $5=$ Lecturer)
D) Years at ECU
E) Years in Rank
F) Department in Which Faculty Member Resides

## NOTE

1) Data is to be separated for nine month and twelve month faculty.
2) Salaries of administrators and the faculty of the School of Medicine are to be excluded from the survey.
3) The predicted salary and the actual salary for each faculty member is to be provided to the departmental chair for those faculty in his/her department.
4) Standard error of the multiple regress and the coefficient of multiple regression, $\mathrm{R}^{2}$ will be provided to each department chair.
