## FIRST READING OF PROPOSED CHANGES IN THE CHARGES OF THE LISTED FACULTY SENATE ACADEMIC COMMITTEES

Proposed Changes to the Charge of the Admissions Committee:
Section 1. Name: Change the committee name to: Admissions and Recruitment
Section 2. Membership: Delete the following: "2 alternate faculty members"; "Elected members must agree to serve at certain times when the University is not in session. Alternate members are appointed to facilitate meeting at these times."

Section 4.A. Committee Functions: Delete the following functions:
4.A.3. The Committee recommends policies regulating the 30 semester hour residence requirement for graduation.
4.A.5. The Committee reviews proposals regarding standards and requirements for admission to and retention in degree programs.

So that the charge will now read:

1. Name: Admissions and Recruitment Committee
2. Membership: 7 faculty members and 1 student member. Ex-officio member: The Chair of the Faculty. Ex-officio members serving without vote but with all other parliamentary privileges are: The Chancellor, the Vice Chancellor for Academic Affairs, the Director of Admissions, the Dean of Continuing Education, and the Associate Vice Chancellor for Undergraduate Studies and Dean of the General College, or their appointed representatives.
3. Quorum: 4 elected members
4. A. Committee Functions:
5. The Committee is concerned with matters related to the admission and recruitment of entering students;
6. The Committee recommends policies, procedures and standards governing under-graduate admissions and recruitment.
7. The Committee serves as an appeals board for entering students who for sufficient reasons cannot meet admission requirements.
B. To Whom The Committee Reports:

The Committee makes its recommendations of policies, procedures and standards governing admissions pertaining to academic regulations and residence requirements for degree programs to the Faculty Senate.
C. How Often The Committee Reports:

The Committee reports to the Faculty Senate on the academic composition of the freshman class and entering transfer students at least once a year, and reports other times as necessary.
D. Power Of The Committee To Act:

The Committee is empowered to make decisions regarding entering student admission appeals. The Committee suggests to the Director of Admissions such research studies as are helpful for evaluation of the efficiency of current practices.
2. Proposed Changes to the Charge of the Credits Committee:

Section 4.A. Committee Functions: Add the following function:
4.A.3. recommends policies regulating the 30 semester hour residence
requirement for graduation.
3. Proposed Changes to the Charge of the Curriculum Committee:

Section 4.A. Committee Functions: Add the following function: 4.A.6. Proposals regarding standards and requirements for admission to and retention in degree programs.
4. Proposed Changes to the Charge of the Student Recruitment and Retention Committee:

Section 1. Name: Change the committee name to: Student Retention Committee Section 2. Membership: Delete the following: "the Director of Admissions"; "and" after General College; Add the following: "and the Chair of the Readmission and Appeals Committee."
Section 4.A. Committee Functions: To read as follows: "The Student Retention Committee is concerned with matters relating to the retention of students. The Committee reviews policies and procedures governing orientation and retention of students."
Section 4.B. To Whom The Committee Reports: To read as follows: "The Committee recommends policies and procedures governing orientation and retention of students to the Faculty Senate."

So that the charge will now read:

1. Name: Student Retention Committee
2. Membership: 6 faculty members and 1 student member. Ex-officio member: The Chair of the Faculty. Ex-officio members serving without vote but with all other parliamentary privileges are: The Chancellor, the Associate Vice Chancellor for Undergraduate Studies and Dean of the General College, the Vice Chancellor for Student Life, or their appointed representatives, and the Chair of the Re-admission and Appeals Committee.
3. Quorum: 4 faculty members exclusive of ex-officio
4. A. Committee Functions:

The Student Retention Committee is concerned with matters relating to the retention of students. The Committee reviews policies and procedures governing orientation and retention of students.
B. To Whom The Committee Reports:

The Committee recommends policies and procedures governing orientation and retention of students to the Faculty Senate.
C. How Often The Committee Reports:

The Committee reports to the Faculty Senate at least once a year and other times as necessary.
D. Power Of The Committee To Act:

The Committee makes recommendations concerning the implementation and administration of policies and procedures regarding the orientation and retention of students to the appropriate University officials.

## 5. Proposed Changes to the Charge of the Teaching Effectiveness Committee:

Section 4.A. Committee Functions: The last sentence to read a follows:
"The Committee is empowered to recommend the procedures by which the recipients of the annual Alumni Association teaching awards are chosen."

FIRST READING OF THE CHARGE OF THE PROPOSED NEW READMISSION APPEALS COMMITTEE

1. Name: Readmission Appeals Committee
2. Membership: 7 faculty members, 2 alternate faculty members and 1 student member. Ex-officio members serving without vote but with all other parliamentary privileges are: The Registrar.
3. Quorum: 4 faculty members exclusive of ex-officio
4. A. Committee Functions:
5. The Readmission Committee is concerned with matters relating to the readmission of students.
6. The Committee recommends policies, procedures, and standards regarding the readmission of students.
7. The Committee serves as an appeals board for students seeking readmission and for continuing students who have been declared academically ineligible to return.
B. To Whom The Committee Reports:

The Committee makes its recommendations of policies, procedures and standards governing readmission of students to the Faculty Senate.
C. How Often The Committee Reports:

The Committee reports to the Faculty Senate at least once a year and other times as necessary.
D. Power Of The Committee To Act:

The Committee makes recommendations concerning the implementation and administration of policies, procedures and standards regarding the readmission of students to the appropriate University officials.

## FIRST READING OF PROPOSED AMENDMENT TO APPENDIX A REGARDING THE agenda commitiee's role in preparing dates for faculty senate meetings.

Page A-5: Omit the following underlined wording under Section IX. of the Constitution.
Four regular meetings of the Faculty Senate will be held each fall and spring semester according to a schedule prepared the preceding year by the Agenda Committee and presented to the Faculty Senate for approval at the second meeting of the spring semester.

Page A-9: Add the following under Section I. of the By-Laws.
F. The dates for the four regular Faculty Senate meetings held each fall and spring semester will be prepared by the Agenda Committee in the preceding year. The Senate will approve the dates for the Faculty Senate meetings of the next year no later than the fourth meeting of the fall semester.

Attachment 5
GUIDELINES FOR SETTING UNIVERSITY CALENDARS
Approved by the Faculty Senate $1 / 26 / 88$
Amended by the Calendar Committee 12/11/89

1. Fall and spring semesters will include at least $14 \mathrm{M}, \mathrm{T}, \mathrm{W}, \mathrm{Th}, \mathrm{F}$, and S. Each summer session will have 25 class days.
2. When appropriate, fall semester will include Labor Day as a holiday, a two-day break appended to a weekend in October, a Thanksgiving holiday beginning no later than 1:00 p.m. Wednesday before Thanksgiving and continuing through Saturday, and a Reading Day between the last day of classes and the beginning of exams.
3. There will be a minimum of a three-week break between fall and spring semesters and a minimum of a one-week break between spring semester and the first session of summer school.
4. When appropriate, spring semester will include Martin Luther King, Jr.'s Birthday and Good Friday as holidays, a break of one week, and a Reading Day between the last day of classes and the beginning of exams.
5. Commencement will be scheduled at appropriate times at the end of both fall and spring semesters.
6. When appropriate, fall and spring semester exams will be scheduled on seven days including Saturday according to a rotation schedule. Exams for each summer session will be held on the day after the last class day.
7. Independence Day will be scheduled as a summer session holiday.

(Policy passed by Executive Committee of the Board of Trustees of the University of North Carolina System on April 11, 1969 and "delegated to the Chancellor of each component institution" by memorandum from President William Friday on February 3, 1971.)
8. Your calendar "shall include two semesters of seventeen weeks each and a summer session of eleven weeks divided into two terms of approximately five and one-half weeks".
9. You "shall have the advice of a student-faculty committee on the calendar".
