The School offers a BS degree with a major in Social Work, a BS degree with a major in Criminal Justice, and a Master of Social Work degree. At the graduate level, students may elect an indirect practice concentration to prepare for roles as managers, organizers, planners or administrators of social services. Research, teaching, and service directed at lifting the levels of people to their highest potential become a single reality in the mission of the hool.




