Errata Sheet

The following are changes in wording to the August drafts of the implementation plans and unit plans. These changes resulted from the special session of the Faculty Senate held on September 4, 1990 and from individual unit revisions to date. This errata sheet does not include all minor editorial changes made by the units.

IMPLEMENTATION PLANS

Enrollment Management Implementation Plan

EM-4, Table 2a: All Undergraduate classification breakdown and all Cohort Survival Rates deleted.

EM-5, Table 2b: "Annual increase in cohort survival rates" should read "Annual increase in class-to-class comparison rates"

EM-5, Table 2b: "First-Freshmen" should read as "First-time Freshmen to other Freshmen"

EM-5, Table 2b: "Freshmen-Sophomore" should read as "Freshmen to Sophomore"

EM-5, Table 2b: "Sophomore-Junior" should read as "Sophomore to Junior"

EM-5, Table 2b: "Junior-Senior" should read as "Junior to Senior"

EM-5, Table 2b: Add the following footnote: "The class-to-class comparison rate is the comparison of enrollment in the current class to enrollment in the previous class of the previous year. For example, the Freshmen-to-Sophomore comparison for 1989 is the following ratio: 1989 Sophomore/1988 Total Freshmen. These ratios reflect the results of both retention and progression as well as any effects that special groups such as transfers and nontraditional students have on enrollment figures."

Facilities Implementation Plan

FA-2, Under Outpatient Clinical Facilities: Change to: "Space is very inadequate for clinical facilities through out campus. While the School of Medicine requires the major portion of such space, allied health programs are also severely impaired by lack of adequate clinical space."

Faculty and Staff Development Implementation Plan

FS-2, number 1.d.: "for all" should read "for new as well as existing"

FS-2, number 1.g.: Change to read: "Review promotion and tenure recommendation process and policies, addressing both criteria and procedures university-wide"

Information Resources Implementation Plan

IR-1, number 1.a.: Change to read: "Prepare students to be functioning members of the information society by making every attempt to instruct all students in the use of computer hardware and software, including operating systems and word processing applications as well as discipline-specific applications software"

IR-1, number 2.c.: Delete: "Implement tenure and promotion policies that"

IR-2, number 6. : "Vice Chancellor" should read "senior officer"

AS-1, number 1.a.: Change to read: "In all courses where such emphases are pedagogically sound, particularly in general education courses, develop curricula which emphasize writing, critical thinking, reading, oral communication, mathematical skills, the ethical dimension of decision-making, the acquisition of knowledge, and life-long learning"

AS-2, number 1.c.: Change to read: "Incorporate international, multiethnic, and gender perspectives into those courses where such emphases are pedagogically sound, and incorporate foreign language study into appropriate undergraduate programs"

AS-2, number 4.a.: Change to read: "Seek permission to plan new PhD programs in history with a special emphasis in maritime history, coastal resources management, English with a special emphasis in rhetoric and composition and in noncanonical literature, medical biophysics, and other disciplines as needed"
