

The projected additions were compiled by the School of Music Planning Committee from suggestions submitted by the Chairs on behalf of their departmental faculties.

For your information, the following programs also were included in the Planning Committee's projections. However, a conference with Ms. Myra Cain of Vice Chancellor Springer's staff confirmed that these projected additions will be considered as tracks already included in the University of North Carolina Academic Program Inventory for East Carolina University. Enclosed within parentheses are the tracks existing under the 1004 music inventory number for which each option will be considered.

DESCRIPTION OF PROGRAM AND RELATIONSHIP TO INSTITUTIONAL MISSION AND UNIT VISION:

Master of Arts track in Cultural Arts Supervision For individuals in Art/Dance/Music/Theatre, leading to certification at the supervisory level

This new track would assist East Carolina University in its goal to "Improve teacher education and stimulate improvement in public schooling." It would allow arts supervisors to be better prepared to increase emphasis on <u>all</u> the arts and to better serve as catalysts for public school reforms in the arts.

The proposed track also relates to the University Goal 5.C., to "Foster collaborative investigations by faculty from different disciplines and institutions."

The School of Music "Vision Statement" includes the stated objectives "to prepare each student for a specialized field, [and] to develop an understanding of the relationship between this speciality and other musical disciplines." The addition of a cultural arts master's program would relate to these objectives and broaden the second one to include developing an understanding of the relationship between music and other cultural arts, as well as "other musical disciplines."

RATIONALE FOR PROGRAM ADDITION/DELETION/REDESIGN:

This unique program would fill a void in the present curriculum and would assist educators in the fine arts through public school programs in North Carolina and other states to further more knowledgeably the cultural life in the community, state and region.

An individual receiving the degree Master of Arts in Cultural Arts Supervision would have the appropriate background for approaching the diverse aspects present among the cultural arts areas. The degree would offer a strong credential on behalf of an applicant for the increasing number of positions available in public schools systems as Supervisor of Cultural Arts. DESCRIPTION OF PROGRAM AND RELATIONSHIP TO INSTITUTIONAL MISSION AND UNIT VISION:

Doctor of Music degree

Program would include tracks in a variety of fields. The fields of specialization would depend upon the stage of development of faculty strengths at the time the degree is proposed to curriculum committees. For example, performance and music education are probable areas for future consideration.

The addition of a Doctor of Music degree would be in line with one of the major University-wide goals, to "Expand doctoral programs," as described in the strategic planning document <u>Strategies for</u> <u>Distinction</u>.

The addition of the doctorate in music would strongly support the School of Music "Vision Statement" by "the fostering of self-realization consistent with the nature of the art and ability, talent, interest, and professional aspirations of the students it serves" and by meeting the stated objectives "to stimulate musical and academic excellence . . . [and] to prepare each student for a specialized field."

RATIONALE FOR PROGRAM ADDITION/DELETION/REDESIGN:

The doctorate in music would enhance the comprehensive atmosphere in the School of Music. It would expand the course offerings and help improve the quality of performance, research, and teaching methodologies throughout the unit.

The need and demand for a doctorate in music in the eastern portion of North Carolina have increased in recent years, and the School of Music not infrequently receives inquiries regarding the availability of such a degree at East Carolina University. The strength and depth of music faculty qualifications continue to increase and should easily meet appropriate standards when the anticipated date of establishment approaches. Doctor of Music
