Dear Chancellor Eakin:

On March 19, 1991, the Faculty Senate adopted, for your consideration, the following resolutions:

✓#91-16 Approval of Spring 1991 Graduation Roster subject to completion of degree requirements.

✓#91-17 WHEREAS, the 1989 national average of full-time counselors in counseling centers for institutions over 10,000 students is 1,723 students per counselor, and

WHEREAS, ECU has experienced within the last two years a reduction in counseling center staff from six full-time professional counselors (doctorate-level) to two full-time professional counselors (doctorate-level), three full-time temporary professional counselors (master's degree-level), and two 1/3-time professional counselors (master's degree-level). The current ratio at ECU is 3,300 students per counselor, and

WHEREAS, ECU falls short of the national norm, and

WHEREAS, there is growing testimony from students, faculty, and staff of the need to increase the core of full-time certified professional counselors in the Counseling Center.

THEREFORE BE IT RESOLVED, that the Faculty Senate recommends that the student/counselor ratio in the ECU Counseling Center be improved by reducing the ratio to meet the national norm.

✓#91-18 Nonmatriculated Student Policy (see Attachment 1)

✓#91-19 Approval of curriculum matters contained in the Curriculum Committee Minutes of February 14, 1991, and February 28, 1991, excluding PHYE 3300. (see Attachment 2 and 3)

✓#91-20 Approval of Appendix U, Sexual Harassment, Discrimination, and Conflicts of Interest Policies. (see Attachment 4)


Other resolutions passed by the Faculty Senate, not needing your approval, were:
