FACULTY SENATE ORGANIZATIONAL MEETING FULL MINUTES

The organizational meeting of the 1992-1993 Faculty Senate was held in the Mendenhall Student Center Great Room on Wednesday, April 15, 1992

## Agenda Item I. Call to Order

Chair John Moskop called the meeting to order at 2:12. Chair Moskop welcomed back the Senators continuing in their service and offered a special welcome to the new Senators. Each new Senator was asked to stand and be recognized.

Agenda Item II. Roll Call
Absent were: Chancellor Eakin, VCAA Springer, VCHS Hallock, VCSL Matthews, Dorsey (Council of Academic Deans), Hough and Wilson (Faculty Assembly Representatives), Łennon (Academie Łibrary Services), Singhas (Biology), Capen (Business), Allen (Communications), Pinkney (Counseling Center), Woods (Geology), Felts and Glascoff (HPERS), Pories (Medicine), Graham (Psychology).

Alternates present were: $0^{\prime}$ Brien for Chenier (Allied Health Sciences), Hunt for Zeager (Economics), McMillan for Holte (English), Donnalley for Collins (Library and Information Studies), Pierce for Engelke (Nursing), Kledaras for Griffin (Social Work).

Agenda Item III. Report of Committees
A. Election of Senate Officers

Worth Worthington (Medicine) Chair of the Nominating Committee, called the Senator's attention to the slate of nominees for Senate Officers. With no nominations from the floor, John C. Moskop (Medicine) was elected 1992-1993 Chair of the Faculty.

Chair Moskop announced the candidates for the office of Vice Chair of the Faculty, Patricia Anderson (Education) and Wes Hankins (Geography and Planning). With no nominations from the floor, Patriciap Anderson (Education) was elected 1992-1993 Vice Chair of the Faculty with 31 of the 42 ballots cast.

Chair Moskop announced the candidates for the office of Secretary of the Faculty, Jeff Jarvis (Music) and Tom Chenier (Allied Health Sciences). With no nominations from the floor, Jeff Jarvis (Music) was elected 1992-1993 Secretary of the Faculty with 22 of the 42 ballots cast.

Chair Moskop introduced a matter of business not listed on the agenda. The Parents Day Committee and the Parents Association asked that the Faculty Senate consider the following proposal in support of parents visiting classes on Friday, September 11, 1992, during the Parents Day weekend activities.

The Faculty Senate recommends that the East Carolina University east campus faculty open classes held on Friday, September 11, 1992, to parents for visitation as part of the Parents Day weekend activities.

Joyce (Past Chair) asked if this should be further clarified to state that it is voluntary. If this is not known at the beginning of the semester, a professor may be surprised. He then offered an editorial amendment to the proposal, inserting the word "voluntarily".

Farr (English) suggested that it would be even clearer to change the proposal to read "Faculty who wish to open classes....".

Joyce (Past Chair) responded that maybe it should read that "Faculty be encouraged to open classes....".

Bailey (Parliamentarian) stated that the chairs within the College of Arts and Sciences have already been asked to ask faculty to open classes on that particular Friday during the Parents Day weekend.

Givens (Allied Health Sciences) questioned if this was restricted only to the east campus. Thompson (Political Science) responded no. The words "east campus" were struck from the proposal as an editorial change.

Jarvis (Music) offered a secondary amendment to the proposal, adding two sentences regarding visitation policies as follows:

It is understood that each individual professor may state his or her visitation policy dependent upon seating restrictions, exams, or other limiting factors, at the beginning of the fall semester in the syllabus.

It is also understood that it will be duly noted in the Parents Day brochure that professors may have restrictions on visitations and it will be the student's responsibility to be informed of each professor's policy.

The secondary amendment passed by a standing vote of 26 to 12 .
The Faculty Senate then considered and passed the following proposal as amended (Resolution \#92-22):

The Faculty Senate recommends that the East Carolina University faculty voluntarily open classes held on Friday, September 11, 1992, to parents for visitation as part of the Parents Day weekend activities.

It is understood that each individual professor may state his or her visitation policy dependent upon seating restrictions, exams, or other limiting factors, at the beginning of the fall semester in the syllabus.

It is also understood that it will be duly noted in the Parents Day brochure that professors may have restrictions on visitations and it will be the student's responsibility to be informed of each professor's policy.
B. Election of Academic and Administrative Committees

Doug McMillan (English) Chair, took a moment to discuss the procedures involved in placing faculty on the academic, administrative and senate committees and referred Senators to the Breakdown of the Academic Committee Membership Ratio (attachment 3, page 8 of the April 14, 1992, Faculty Senate Agenda). He stated that brief statements from each candidate were extremely helpful and provided the committee with accurate information on each candidate. He recommended that the committee continue with the same procedures next year. He also took a moment to thank Mrs. Lori Lee (Faculty Senate Secretary) for all of her assistance during the nomination process. He then directed the Senators' attention to the slate of nominees for the Academic and Administrative Committee vacancies.
