John Moskop, Chair of the Faculty, has charged the Educational Policies and Planning Committee with investigating the challenges of pursuing continuing growth in enrollment and maintaining academic standards during a period of limited budget increases. The Committee was asked to submit a report to the Faculty Senate February 23, 1992, detailing recommendations for specific actions.
- 7. Members of the Faculty Senate observed a moment of silence in memory of Professor John Poindexter (English), the first Chair of the Faculty (1965-1966), who passed away in Virginia in August.
- C. Richard Eakin, Chancellor's Report

The Chancellor opened his remarks with a commendation to the Student Stores for its contribution of \$185,000 to student scholarships. Dr. Eakin continued with a report which summarized important decisions which occurred over the summer months.

1. Modifications to the Racial and Ethnic Harassment policy. The effect

of this Summer's Supreme Court decision in the St. Paul case was to render certain provisions of ECU's recently passed Racial and Ethnic Harassment policy unconstitutional. Accordingly, the Chancellor recommended to the Board of Trustees that sections II. B. (a) and II. C. 1. be removed from Appendix W. Additionally, the entire policy has been referred to the Faculty Senate for review to determine if further changes are required.

2. Changes in Enrollment for Fall 1992. The Chancellor began by reviewing the breakdown by category of the enrollment increase of 1070

students. It was noted that 515 (48%) of these are entering freshmen, 296 (28%) are within other categories of undergraduates (notably readmissions and retentions), 150 (14%) are entering transfer students, and 109 (10%) are new graduate students. Dr. Eakin noted the unexpectedly high number of entering freshmen. This figure is remarkably high because the average SAT scores of the 1992 entering class reflect an increase from 889 to 900. While this trend would normally reduce the yield rate, that was not so this year. The yield rate increased to 42.5%, reflecting the increase in the yield rate for out of state students. This portion of the report was concluded with suggested reasons for the increase in both average SAT scores and yield rates, some of which were: raising of standards, combined with an image change; improved publications and better mailings; increasing recruiting support from alumni, faculty, students and administrators; enhanced recruitment of community college students. (Note: Copies of the display charts from the Chancellor's presentation are on file in the Faculty Senate office.)

- 3. Maintenance Budget. The Chancellor announced the approval of 1.3 million dollar maintenance budget for ECU by the Board of Governors.
- 4. Todd Dining Hall. The bond sale for the dining hall was approved at the Board of Governors meeting.

During the question and answer period that followed the Chancellor's remarks, Harris (Foreign Languages) asked about a recent investigation into the air quality within the General Classroom Building. Dr. Eakin reassured Harris that the results of the study of the building would be reviewed and that appropriate steps would be taken.

D. Vice Chancellors' Reports

Dr. Marlene Springer, Vice Chancellor for Academic Affairs, announced various newcomers to the campus as well as those operating in new roles. These include Dorothy Clayton, Coordinator of Faculty Development Programs; Jon Heise, Director of International Programs; and Jo Allen, Acting Director of Student Learning Assessment and Academic Program Review.

These announcements were followed by updates on the progress of two groups. First, it was noted that the joint Division of Academic Affairs/Faculty Senate Committee, which is working on a revision of the undergraduate academic regulations, is nearing the point of bringing its report to the Faculty Senate. Additionally, the Advising Task Force is close to presenting its report.

Dr. Springer continued by announcing the appointment of a special committee to study enrollment management issues. Membership includes: Byron Coulter, Michael Dorsey, Phyllis Horns, Gilbert Moore (ex officio), Dorothy Muller, James L. Smith, Scott Snyder, John Swope, Malcolm Tait, David Watkins (chair), and Linda Wolfe.

Dr. Springer concluded by reviewing the challenges ahead for the 1992-93 academic year, which were outlined in her remarks during the opening Faculty Convocation: 1) Continue to recruit academically qualified students to the University, while assuring them a reputable academic schedule; 2) Provide appropriate staffing for the academic computing laboratories; 3) Continue our efforts in faculty development with special emphasis being placed on enhancing teaching effectiveness; 4) Continue to enhance the University's international programs as a new Director of International Programs provides leadership; 5) Support a multi-media center to assist faculty with developing lecture and off-campus presentation materials; 6) Work to continue to plan and gradually implement the new programs we have.

Dr. James Hallock, Vice Chancellor for Health Sciences, stated that he did not have any remarks but was available for questions.

Dr. Al Matthews, Vice Chancellor for Student Life, stated that he did not have any remarks but was available for questions.

E. Ron Speier, Dean of Students, on the Academic Integrity Policy Dean Speier reported on the history and philosophy behind the current Academic Integrity Policy, which establishes procedures for responding to instances of academic misconduct, including cheating and plagiarism. He noted that there are some faculty who may not be aware of the policy or of its implications, expressing a concern that the policy is being underutilized across campus. Dean Speier referred faculty to the Policy which is found in the Faculty Manual, Appendix N, and in the Student Handbook, which was distributed to Senators at the meeting. He also distributed a brochure developed by his office defining violations of Academic Integrity. Additional copies of this brochure may be obtained through the office of the Dean of Students.

F. Ken Wilson, Faculty Assembly Report

Ken Wilson (Sociology and Anthropology) presented a summary of the April 24, 1992, Faculty Assembly meeting. A complete report is available for review in the Faculty Senate office.

Agenda Item IV. Unfinished Business

Chancellor Eakin spoke to his response to Faculty Senate Resolution #92-16, Appendix D: Tenure Policies and Regulations of ECU, reviewing the history of the revised Appendix D since its passage in the Faculty Senate in April 1992, and reading the amendments which he was proposing for the document. Finally, he appealed to the Faculty Senate for its support as the process begins of securing the Board of Trustees' support and ultimately the Board of Governors' approval for the revised Appendix D.

Sexauer (Art) made a motion to amend Faculty Senate resolution #92-16, as suggested by the Chancellor, to include the following revisions: 1. On page 17, substitute the following for footnote 4.:

> Material procedure irregularity is a departure from procedures prescribed in Section IV of this Appendix that casts reasonable doubt upon the decision not to reappoint or not to recommend the granting of permanent tenure.

> Appeals based on material procedural irregularity shall refer only to personnel actions which are initiated after the approval of material procedural irregularity as a basis for a Request for Hearing.

- 2. On page 17, the last two lines of the first paragraph under V. B.2. would be amended to read "irregularity. 4" That is, the material which reads "or (c) the decision was based on a violation of academic freedom." would be deleted.

3. On page 18, the fourth paragraph under V.C. would be amended in lines 8 and 9 to delete the copy ", or was a result of the denial of academic freedom of the affected faculty member."

Discussion of this motion proceeded on two issues, first concerning the specific relationship of the timing of appeals and the approval of the document. This discussion led to a rewording reflected above by the use of the term "personnel actions" in the second paragraph of the footnote.

The second issue of discussion was the removal of "academic freedom" as grounds for a grievance under this document. During the discussion of this issue, Farr (English), Hughes (Business), and Atkeson (History) raised questions about how removing this ground for appeal would affect protection of "academic freedom".

In response to their questions, Chancellor Eakin pointed out that in the context of a personnel decision, "academic freedom" is an elusive concept to define legally, and as such it fails to have the support of the UNC General Administration's legal counsel or the Board of Governors as grounds for an appeal over a denial of tenure or a nonreappointment. There are certain types of speech, protected under the First Amendment, which are a subset of the larger category of "academic freedom." These rights are grounds for appeals within the procedures outlined in the revised Appendix

Bailey (Parliamentarian) added as a point of order that while the UNC system and ECU fully support the protection of "academic freedom," that protection is found within Appendix E, and recourse in case of violations of that policy are to be found with the Faculty Affairs Committee.

Wilson (Faculty Assembly Rep.) stated that in a legal sense, the decision to not reappoint or the denial of permanent tenure is not considered a penalty, because the University is under no obligation to take these actions. Appendix E offers protection from punishment due to the exercise of "academic freedom."

The motion to amend Faculty Senate resolution #92-16, Appendix D: Tenure Policies and Regulations of ECU was carried (Resolution #92-23).

Students may be permitted to enroll in the University under a performance-based admission policy provided their high school class graduated three or more years prior to the expected date of entry and they meet one of the following stipulations:

have had no previous college experience, or
have previous college experience but have not been matriculated within the past one year and are eligible to return to the previous institution but do not meet all stated university admission requirements, or
have had previous college experience, are not eligible to return to the previous institution, and have not been matriculated at the collegiate level for at least three years prior to the expected date of entry.

In order to continue enrollment as degree seeking students, nontraditional students must satisfy all regular admission requirements or achieve a minimum cumulative grade point average of 2.2 and meet all admission stipulations by the end of the semester in which the twenty-eight semester hour of degree creditable work is attempted. Failure to meet either the grade point average requirement or to remove the admission stipulations will result in the student's being ineligible to continue enrollment at East Carolina University.

Students enrolling under this policy must comply with all university policies regarding the payment of tuition and fees and must comply with NC state law concerning health and immunization.

RESOLUTIONS PASSED AT THE SEPTEMBER 15, 1992, FACULTY SENATE MEETING

#92-23 Revision of Faculty Senate Resolution #92-16, <u>Appendix D</u> to include the following amendments: 1. On page 17, substitute the following for footnote 4.

> Material procedure irregularity is a departure from procedures prescribed in Section IV of this Appendix that

> casts reasonable doubt upon the decision not to reappoint or not to recommend the granting of permanent tenure. Appeals based on material procedural irregularity shall refer only to personnel actions which are initiated after the approval of material procedural irregularity as a basis for a Request for Hearing.

- 2. On page 17, the last two lines of the first paragraph under V. B.2. would be amended to read "irregularity. 4" That is, the material which reads "or (c) the decision was based on a violation of academic freedom." would be deleted.
- 3. On page 18, the fourth paragraph under V.C. would be amended in lines 8 and 9 to delete the copy ", or was a result of the denial of academic freedom of the affected faculty member."

#92-24 Revised Nontraditional Student Policy as follows:

Students may be permitted to enroll in the University under a
performance-based admission policy provided their high school
class graduated three or more years prior to the expected date
of entry and they meet one of the following stipulations:
 1. have had no previous college experience, or
 2. have previous college experience but have not been
 matriculated within the past one year and are eligible
 to return to the previous institution but do not meet
 all stated university admission requirements, or

3. have had previous college experience, are not eligible to return to the previous institution, and have not been matriculated at the collegiate level for at least three years prior to the expected date of entry.



In order to continue enrollment as degree seeking students, nontraditional students must satisfy all regular admission requirements or achieve a minimum cumulative grade point average of 2.2 and meet all admission stipulations by the end of the semester in which the twenty-eight semester hour of degree creditable work is attempted. Failure to meet either the grade point average requirement or to remove the admission stipulations will result in the student's being ineligible to continue enrollment at East Carolina University.

Students enrolling under this policy must comply with all university policies regarding the payment of tuition and fees and must comply with NC state law concerning health and immunization.

Nontraditional students are assigned for advisement to the University College. Upon completion of admission stipulations, they are reassigned to the General College or to the school/ department of their intended major. Disposition: Chancellor
