# FULL MINUTES OF JANUARY 25, 1994

The fifth regular meeting of the 1993-94 Faculty Senate was held on Tuesday, January 25, 1994, in the Mendenhall Student Center Great Room.

### Agenda Item I. Call to Order

Chair Patricia Anderson called the meeting to order at 2:10 p.m.

## Agenda Item II. Approval of Minutes

The Faculty Senate minutes of the December 7, 1993, were approved as distributed.

# Agenda Item III. Special Order of the Day

A. Roll Call

Senators absent were: Chancellor Eakin, Vice Chancellor Springer, Faculty Assembly Representatives Bailey and Campbell, Professors Stellwag (Biology), Holte (English), Woods (Geology), Gallagher (Human Environmental Sciences), Markello (Medicine), Simon (Political Science), and a representative from Continuing Education.

Alternates present were: Professors McIntyre for Killingsworth (Business) and Ayers for Evans (Chemistry).

- B. Announcements
- . The resignation of Professor George Bailey (Philosophy) as Parliamentarian of the Faculty was

acknowledged by the Chair of the Faculty, Patricia Anderson. She stated that the Faculty Senate appreciated Professor Bailey's service during the Fall semester in this important role. She then introduced Professor Margaret Stangohr (Health Sciences Library) who agreed to assume the duties as Parliamentarian for the remainder of the academic year. The Senators welcomed Professor Stangohr with a warm round of applause.

- 2. On December 13, Patricia Anderson, James LeRoy Smith, and Marlene Springer visited representatives of the General Administration to discuss the status of Appendix D. Both editorial and substantive changes were recommended for the proposed document. On January 20, Patricia Anderson sent a list of these suggestions for change to the Faculty Governance Committee for their review and discussion. The Committee will submit a revised document to the Faculty Senate this spring. Interested persons are welcome to attend the Faculty Governance Committee meeting scheduled for February 9, at 3:00 in Rawl Annex, #142.

According to the newly revised Appendix L, East Carolina University Code, (dated December, 1993), guidelines are to be established by the Faculty Senate to assist the faculty of a professional school who may democratically decide to organize into self-governing, autonomous units at the departmental level. The Chair of the Faculty will form an Ad Hoc Committee, made up of members from both the Faculty Governance and Unit Code Screening Committee, to formulate these guidelines and present a report to the Faculty Senate by September, 1994.

C. Marlene Springer, Vice Chancellor for Academic Affairs Vice Chancellor Springer was out of town attending a meeting of the Association of State Colleges and Universities in Tucson Arizona.

## D. James Hallock, Vice Chancellor for Health Sciences

Vice Chancellor Hallock addressed issues related to health care reform, both nationally and in North Carolina. He noted that during its last session the North Carolina legislature created a Health Care Planning Commission for the state of North Carolina, comprised of the governor, lieutenant governor and twelve members of the legislature. This Commission will be responsible for much of the activity and legislation surrounding health care reform within the state. Hallock noted that Dr. Jim Jones (Chair of School of Medicine's Department of Family Medicine) has been chosen as executive director for this commission and began his duties February 1, 1994. In his absence Dean Patton will serve as the chair of the Department of Family Medicine.

E. J. Craig Souza, Chairman of the East Carolina University Board of Trustees Mr. Souza opened his remarks with a reference to the parking pressures around Mendenhall Student Center. He brought praise for the recent representatives of the Faculty Senate to the Board of Trustees, Conner Atkeson, Jim Joyce, John Moskop, and Patricia Anderson. Mr. Souza also recognized the importance of the faculty to the university and to its continued growth.



Following these brief remarks, Souza responded to questions from Senators. Bell (Education) asked what the colleges and schools could do to make the board's job easier and the institution more effective. Souza responded that more interaction between the board and faculty would be desirable.

Ferrell (History) followed with a question about arranging for Board members to visit with faculty members on campus. He noted the concern of faculty that such a meeting not be seen as an attempt to bypass the administration. Sousa responded that he would seek approval from the Board for a special trustee-faculty committee, an informal group representing both trustees and faculty.

McPherson (Industry and Technology) expressed his concern about the recent initiative from the legislature which seems to mandate that a student graduate in four years. He noted that with many of our students, working while in school is necessary making this demand even more difficult to accomplish. Souza responded that although the Board of Trustees had nothing to do with the legislation, he could see the economic issues motivating it. He indicated that he understood the action of the legislature to be a signal to the University system that four years is a goal, and that student careers of six and seven years are not normative.

Wolfe (Anthropology) asked about the Board of Trustees perception of its role in tenure and promotion. Souza noted that his response was as a single member of the Board, and that his approach was to trust the recommendation of the Chancellor. He noted the difficulty for a Board member to evaluate the effectiveness of individual faculty. However, appeals of tenure decisions receive a great deal of time, energy and scrutiny from Board members.



Zeager (Economics) asked about other duties of the Board, beyond tenure and promotion. Souza noted that the Board is responsible for the budget of the university, any physical plant buildings, parking, all fees, general university policy, hiring head football and basketball coaches, and advising on the hiring of vice-chancellors.

Atkeson (History) asked about the possibility of the faculty representative to the Board sitting in on executive sessions of the Board, a privilege extended to the SGA president. Souza noted that the Board was restricted by state law as to executive sessions. As state employees, faculty may not serve as members of the Board, therefore, faculty have been excluded from executive session meetings.

Hallock (Vice Chancellor for Health Sciences) moved to amend the proposed revisions by changing "Chancellor" to "appropriate Vice Chancellor" in each place it occurs in the procedures section of the revisions. The motion to amend was seconded and passed.

Ferrell (History) recommended an editorial change, replacing the term "should" with the terms "will" or "must" throughout the revisions. This change was accepted without objection.

Ferrell (History) moved to amend the proposed revisions by changing the Procedures section, 5.b., first line to stipulate that the Panel shall consist of three (3) members and 7.a., first line to stipulate that the Committee shall consist of five (5) members. The motion to amend was seconded and passed.


