RE: Tenure Status of Faculty

In response to your request from this past summer, the two attached tables provide information on the tenure status of the faculty for the past ten years. One table includes faculty from the School of Medicine. The second one does not.

There are several points that I would like to make regarding these data. As much as I would like, the numbers were not generated in entirely comparable ways for each of the years. This is due in part to changes in the way in which faculty are counted or coded in the personnel data file. For example, three years ago my staff noted that some departmental chairs were coded as faculty, some were coded as administrators. This resulted in our changing the codes for all department chairs to that of administrator. Since these tables concern only faculty and administrators with faculty rank and tenure are excluded, the numbers for the earlier years are inflated in comparison to the numbers for the last three years. Similarly, librarians were not coded as faculty in the mid-1980s and that has now changed.

As this trend data will be of continuing interest to a number of individuals on campus, it will be included in the *Factbook* beginning this year. If there is additional information that you or members of the Faculty Senate would like, please feel free to contact me.
