RE: Revised Tenure Status Tables

Last week I showed the tables I forwarded to you to the Administrative Council. Based on some of the comments I received, I have had the tables revised to reflect more completely the tenure status of our faculty. The earlier tables did not include individuals on temporary appointments and did not calculate FTEs. The attached revised tables include these data and are, therefore, more complete.

I mentioned in the previous memo that one factor in the shifting of the percentages was the changing of how administrators with tenure were coded beginning in 1993. This change alone moved a net 55 individuals from the tenured faculty rank to the tenured administrator category. This change had the consequence of removing those individuals from being counted in these tables for the 1993 and 1994 years even though they had been counted previously.
