On the recommendation of the University-wide Implementation Committee on Enrollment Management and as an experiment in total quality management, Chancellor Eakin has established the Enrollment Services Council. The membership by position of the council and the associated "teams" are listed on the attachment to this newsletter. James LeRoy Smith will serve as interim chair until a permanent vice chancellor for academic affairs is appointed, after which time a decision will be made on a permanent chair of the Council.

The leading idea behind the creation of the Enrollment Services Council [ESC] is that seamless quality control and continuous quality improvement should exist over all enrollment services provided to our students from recruitment to their experiences as alumni. The teams have a descriptive model of the "inputs, processes, and results" for their respective areas and will be developing that model as they meet and discuss how well we now do and where we might make advances in order better to serve our students.

The Council has met three times over the spring and early summer and the respective teams will be convened soon to begin their discussions. This newsletter is the vehicle by which we now ask team members, identified by position on the attached sheet, to serve. The Vice Chancellors are encouraged to attend

at least the first team meeting on which they or their delegates serve before deciding on delgation. Team leaders will be convening the teams sometime in July.

The Council will meet bi-monthly and will issue a monthly newsletter that describes activities, discusses issues, and reports on any recommendations that it may forward to the Chancellor and the Vice Chancellors.

The Council is empowered with the following charge: "The Enrollment Services Council is responsible for developing and implementing the enrollment management model, for regularly informing the Chancellor and the Vice Chancellors on all matters pertaining to enrollment management, and for recommending to the Chancellor on any appropriate aspect of enrollment management. The ESC is also charged with recommending to the Chancellor the membership, beyond the respective team leaders, of the four teams."

The teams will convene focus groups beyond team membership to consider and develop relevant areas of enrollment services.
