Dear Professor Sexauer:

Relative to the code of the School of Health and Human Performance, it is my desire to retain the current administrative structure in the school with the Human Performance Laboratory maintaining its status as a research and service center *reporting directly to the dean*. In my reading of the code approved by the Faculty Senate, this will require revisions to section V; however, I would ask that the school and the unit code screening committee carefully review the code to ensure that other sections are not impacted in ways that would be inconsistent with this administrative structure. Aspects of the code that are not inconsistent with the direct reporting of HPL to the dean meet with my approval.

I, therefore, am returning the code of the School of Health and Human Performance for revision to reflect the administrative structure described above.
