FULL MINUTES OF 27 JANUARY 1998

The fifth regular meeting of the 1997-98 Faculty Senate was held on Tuesday, 27 January 1998, in the Mendenhall Student Center Great Room.

Agenda Item I. Call to Order

Chair Don Sexauer called the meeting to order at 2:10 p.m.

Agenda Item II. Approval of Minutes

The minutes of 9 December 1997, were approved as distributed.

Agenda Item III. Special Order of the Day

A. Roll Call

Senators absent were: Professors Wolfe, Ulffers, Chancellor Eakin, and Vice Chancellor Feldbush.

Alternates present were: Professors Mott for Joyner (Education), Jones for Farr (English), Ciesielski for Hankins (Industry and Technology), and Johnson for Wilson (Sociology).

B. Announcements

1. Chancellor Eakin is in Chapel Hill today attending an UNC Administrative Council meeting.
2. The Committee on Committees has been charged to seek volunteers to serve on the various academic, appellate, administrative, Board of Trustee, and student union committees. Faculty have received volunteer packets, with brief descriptions of the University committees, and are strongly encouraged to participate in this component of shared faculty governance.
3. Letters concerning unit elections for the 1998-1999 Faculty Senate representation will be mailed to unit code administrators this week. 5. Chancellor Eakin has approved the following resolutions from the December 1997, Faculty Senate meeting:
 - #97-40 Neither the new Academic Eligibility Standards nor their penalty structure be implemented at this time. The Enrollment Services Council, with its current faculty and Senate committee representatives and relevant administrators, plus a delegate from the Credits Committee and a person who is primarily concerned with minority enrollment, should be charged with reporting to the Faculty Senate by April 15th. on an alternative plan that will endeavor to raise the University's academic standards in a manner that avoids the degree of substantive risk apparent in the current plan, and that the Enrollment Services Council should solicit and consider written faculty advice on strategies to improve retention. Such advice might include higher standards than the current ones, but not as high as the previously proposed new standards. Also, postponement of suspension until later in the sophomore year to permit students to focus longer on academic improvement may have merit.
 - #97-43 Revision to the *ECU Faculty Manual*, Appendix C., Section I.C. and Section III.
 - #97-44 December 1997, graduating senior candidates to be designated "Honors Program Graduates", subject to the completion of degree requirements.

C. Vice Chancellor's Report

Vice Chancellor Richard Ringeisen made remarks about appointment of Gary Lowe as Interim Dean of the School of Education; ECU meeting the criteria for designation as a Doctoral II University but the General Administration not recognizing such as of yet; new degrees being planned and ones being established are in the final phases of consideration including the Bachelors in Construction Management, doctorates in Coastal Resource Management and Biomedical Physics; phased retirement soon being implemented and a letter to those eligible forthcoming from the Chancellor. He noted that all previous indications of interest in early retirement are insufficient and those interested in participating will have to apply after notification from the Chancellor. VC Ringeisen also noted that ECU was sending a team to the Association of Higher Education meeting in Florida.

Rosenberg (Faculty Assembly) asked how many people are eligible for phased retirement and how would it impact the University. The vice Chancellor responded that there were currently 234 faculty eligible and that no more than 10% of the faculty may participate at any one time.

Vice Chancellor James Hallock made remarks about the Mini-Medical School coming in March to allow the community to visit and learn about activities of the Medical School. A Clinical Assessment Facility was initiated recently and will serve as a test site for assessment of student performance in health-related disciplines.

Agenda Item IV. Unfinished Business

There was no unfinished business to come before the Faculty Senate at this time.

Agenda Item V. Report of Committees

A. Committee on Committees

Mark Taggart (Music), Chair of the Committee, presented the two nominees to fill the upcoming alternate Faculty Assembly positions. There was no discussion and the two nominees, Jeanette Dolezal (Medicine), and Bob Woodside (Math) were elected as Faculty Assembly alternates by acclamation.

B. Credits Committee

Bob Woodside (Math), Chair of the Committee, presented the proposed revision to the *Undergraduate University Catalog*, Section 5: Academic Regulations. Ferrell (History) asked about the 15% cap on correspondence courses and suggested an editorial change adding the phrase ", unless the student's major requirements specify otherwise." Allred (Psychology) questioned the change. Schadler (Business) expressed a view that the statement already set a limit of 15%. Simon (Political Science) suggested that there should not be a change. Ferrell (History) moved to include an editorial change. Rosenberg (Faculty Assembly) suggested that the courses should be left to the discretion of the supervising faculty. The editorial change was rejected by the group. Following discussion, the proposed revision to the *Undergraduate University Catalog*, Section 5: Academic Regulations was approved as presented. **RESOLUTION #98-1** (Please refer to the list of resolutions at the end of this report for the full revision.)

C. Educational Policies and Planning Committee

Don Sexauer (Art), member of the Committee, presented the committee's approval of the request for authorization to plan a new degree program as a Undergraduate Multidisciplinary Minor. There was no discussion and the Committee's report was accepted as presented.

D. Unit Code Screening Committee

Bill Grossnickle (Psychology), Chair of the Committee, presented the proposed revised School of Education and Department of History's Unit Code of Operations. There was no discussion and the revised School of Education and Department of History's Unit Code of Operations were approved as presented. **RESOLUTION #98-2** (Copies of these codes are available for review in the Faculty Senate office, 140 Rawl Annex.)

E. Ad Hoc Committee to Review Model Computer Use Policies

Henry Ferrell (History), chair of the Ad Hoc Committee, presented a synopsis of the proposed policy, then asked to withdraw the policy from the agenda to allow the Ad Hoc Committee more time to review the issues involved. The policy will be reviewed by the Ad Hoc Committee, Faculty Officers, Chancellor Eakin, and the University Attorney and will be returned to the Senate for further consideration and action in February.


Agenda Item VI. New Business



RESOLUTIONS PASSED AT THE 27 JANUARY 1998, FACULTY SENATE MEETING.

- #98-1 Revise the *University Undergraduate Catalog* by adding the following as a new subsection to Section 5: Academic Regulations, following subsection entitled *Currently Enrolled East Carolina University Students* (page 44):

"Independent Study

Independent study is defined as any program of study without direct instruction in a classroom setting (excluding internships). It may include directed readings, special topics courses, or independent study of an existing course. The use of independent study should be limited to two occasions: 1) when a student wishes to pursue a topic of study which is not available in an approved course or 2) when a course is needed to satisfy graduation requirements but the course is not being offered in a timely manner to satisfy those requirements. Independent study and correspondence credits may not exceed 15 percent of the total hours required for the degree. (See *Currently Enrolled East Carolina University Students*, above.) Credit earned through independent study cannot be used to reduce the minimum residence requirement.

All independent study courses should be set up as a part of the departmental schedule of courses for the respective term. Independent study sections of normally offered courses should be appropriately noted by section number."

Also add the following to subsection entitled *Currently Enrolled East Carolina University Students* (page 44) after "Approval will not be granted for correspondence courses beyond 15 percent of the total hours required for graduation."





- #98-1 Revise the *University Undergraduate Catalog* by adding the following as a new subsection to Section 5: Academic Regulations, following subsection entitled *Currently Enrolled East Carolina University Students* (page 44):

"Independent Study

Independent study is defined as any program of study without direct instruction in a classroom setting (excluding internships).
