 - 1. General Education How will the provost's funding model affect departments that lose courses as a result of General Education changes? What role do the Faculty Senate and the Academic Standards Committee play vis-à-vis the Deans and Directors?
 - 2. Parking Faculty have had little opportunity to view the new parking proposal. The proposal to offer the core campus parking to students if faculty won't pay the increased fee isn't sitting well with the faculty. This would undermine the morale of the faculty. Before this is adopted there should be opportunity for the Faculty Welfare Committee to view the plan and make recommendations to the Faculty Senate. This should be a deliberate process, rather than one where the Faculty Senate is expected to adopt, or not adopt a plan in one session.
 - 3. Non-tenure track faculty issues.

This will be proposed as New Business at the Nov. 4 FS meeting.
