

I request that you serve on a committee to advise me on the best approach to filling the position of Vice Chancellor for Student Life. I am asking Jim Smith to chair the committee.


Our options include a national/international search, a more limited regional or state-wide search, an internal (to ECU) search, or a waived search with a direct appointment.


