Dear Chancellor Ballard:

Enclosed are the University Budget Committee's budgetary recommendations for the academic year 2009-2010. In these difficult economic times, the Committee appreciates the open and candid manner with which you and your administration have embraced the work of the Committee. The members recognize that the current budget environment precludes any of us from knowing the full extent of budgetary issues confronting East Carolina University until the close of each fiscal year. The Committee also recognizes your efforts in minimizing the effects of budgetary cuts on the academic mission of ECU with particular emphasis on student, staff, and faculty employment. Your administration's interactions with the Committee have provided the transparency necessary for shared governance. This environment has made it possible for the Committee to provide you with what we believe to be sound and timely advice.



Recommendations

- Budget cuts and allocation of new funding should be made in line with the Value Statement of the Board of Governors and the Board of Trustees policy framework for resource allocation that protect to the greatest extent possible the academic core and our commitment to teaching, research, and service.
- Budgetary cuts should minimize any adverse effects on student learning or the safety of students and University personnel.
- Consistent with the views expressed by your administration, budgetary cuts should seek to prevent or if necessary minimize reductions in force.
- 4. It is important to continue open lines of communication and transparency among all constituencies (students, staff, faculty, and administration) of the University.
- Budget cuts should minimize damage to the University in ways that are not easily reversed upon the return of an improved economy.
- Budgetary cuts should be avoided that adversely affect areas of revenue generation including but not limited to student credit hours, grants and contracts, and medical services.



7. The University should continue to review efficiencies to realize cost-savings.

- The Budget Task Force should remain in place until the budget outlook has improved.
- The University should continue to pursue appropriate state reimbursement for indigent care provided by ECU Physicians.
- The University should continue to pursue appropriate state funding of the dental school.

Dear Dr. Gavin,

Thank you for the recommendations of the committee and your cover letter. I think the recommendations are excellent and will ask Academic Council and Vice chancellor Seitz to consider them very carefully. My initial reaction is very positive. I will ask Provost Sheerer and Dr. Walker to review the budget task force with the goal of reconvening one (the same or modified...up to them) at least for the summer months... most of the state news will occur between May 12th and August 1.

Regarding recommendation # 3, I will make some remarks tomorrow on this. If we take a 5% base cut for next fiscal year, our plan calls for losing 97 FTE positions, all of them vacant. While we will continue to seek ways to minimize this loss, I believe the cumulative impact of such a large base cut would require this kind of drastic action. President Bowles also views the loss of positions to be inevitable under this scenario; he estimates a loss of 1000 jobs system wide.

We won't give in to this probability, but I want to let everyone know that we face this kind of circumstance, given the state revenue picture of the moment.
