



Previously Faculty Senate Resolution 10-08 was held pending revisions to the Final Examination section (see March 24, 2010 memorandum). With the approval of Faculty Senate Resolution 10-78, I am also approving Faculty Senate Resolution 10-08 with the revised wording contained in Resolution 10-78.

Further, the Academic Council and I concur with the Faculty Manual Steering Committee's recommendation that the Chair of the Faculty ask the appropriate committee to address two additional issues: 1) the inclusion of a statement that the chair of the department is responsible for monitoring adherence to scheduled examination requirements, and 2) the inclusion of an exception to the printed university schedule for clinical and non-traditional class schedules, including graduate level courses.
