Revisions to the *ECU Faculty Manual*, Part VI. General Personnel Policies, Section I. Employment Policies, Subsection J. Salary Policies.

Faculty Senate Resolution 12-76

Revisions to *ECU Faculty Manual*, Appendix C. Section III. Evaluation in reference to the Student Perception of Teaching Survey.

Faculty Senate Resolution 12-65

Revisions to the *ECU Faculty Manual*, Part I. Introduction.

In the third paragraph, add quotes to the statement "as an organized voice for the faculty of East Carolina University to enable faculty to play a broader role in the decisional mainstream of the institution."
