9:00 Faculty Assembly Convenes Welcome and Meeting Overview (Catherine Rigsby)

Dr. Rigsby greeted the delegates and notified them of alterations of the schedule. Three potential resolutions are circulating for consideration this afternoon.

9:10 Suzanne Ortega, Vice President for Academic Affairs (30 minute) Academic Aspects of the Strategic Plan and Q&A with Delegates

Articulation agreement with community college system discussed as it relates to the strategic directions committee. Thanks members for their hard work.

Comprehensive Articulation: Fall. 2014, a revised Comprehensive Articulation Agreement should be ready to go. Last six months spent gathering data. Research and Policy portions are complete. 2 or 3 fundamental questions remain, i.e. moving from a "Core 44" to a "Core 30" option. Try to identify courses most central and needed for a GenEd core. Identify what is most common for pre-majors. Only one course so far approved, ENG 101. These 30 hours could be transferred as GenEd requirement. In January, will begin launching faculty disciplinary panels, starting with ENG 101. Panels for mathematics, sociology history and biology will also be needed.

Q: Why no foreign language courses in the first 30 hours? Where does it fit on this agenda?

A: Much of GenEd choices are related to majors.

Documents of strategic directions extremely "thoughtful." There is consistency with broad based goals between faculty and strategic planning document. Goal to become one

of the top educated states was discussed.

Academic quality goals: increase transparency in assessment process.

Discuss common student learning outcomes among campuses.

Be a national leader in using instructional and educational technology.

Career and academic advising goals: creating advising portfolios. Need for more advisors.

9:40 Kate Henz, Senior Director for Academic Policy and Funding Analyses, and Dan Cohen-Vogel, Senior Director Institutional Research (20 minutes)
Setting (and reaching) Attainment Goals and Q&A with Delegates

Focus last two months was to anchor a strategic plan with needs for the state. Balance between value of higher education and workforce needs. Focus on the components of the degrees.

What are workforce demands? Data on this varies. Try to project needs in the future. Adopted a direction of 32% of population will have baccalaureate degree by 2018. Then by 2020, 2025 and beyond, 36-38% will have a degree.

Q: What point in the next five years do we get to 32%?

A: 2-3% annual growth rate of obtaining degrees.

Q: What are other option serving needs besides degree attainment?

A: Demographics are changing, but must be prepared to deal with these changes.

Q: How much will our institutions have to expand to handle this growth and change (+900 degrees a year) in demographics?

A: 2-3% a year growth is a strategic direction.

Called in sick this morning. Kemery Lyon gave the report. Pell grants will be spared. Still waiting for "deal" from national leaders. Concerned about possible cuts to discretionary funding, which supports research. New congressional delegates discussed. 60% of General Assembly in first or second term.

The goal is "The perfect General Education program." Two GE models: Common core, and areas to select from. Ease of transfer of courses from community college to UNC and measurable assessment of outcomes are two goals. Common competencies are in place. Teaching approaches are as important as curriculum.

Should there be a common Gen Ed program of 30 identical hours for each student in the system?

No.

Should there be common competencies or skills required?

Do you want processes or knowledge? Each institution has different admission standards.

How do we demonstrate that students are achieving competencies?

Courses students take require these competencies. Having an Office of Assessment, student portfolios are possible methods. Find ways to make student learning visible to other constituencies.
