This resolution is approved, with the exception of the charge of the Admissions and Retention Policies charge. The changes in the Admission and Retention Policies Committee charge conflicts with the roles and responsibilities of the Graduate Council, as outlined in the Faculty Manual, which could cause confusion surrounding the role of the Graduate Council. The charge of this committee should be amended and resubmitted to correct this issue.

Faculty Senate Resolution 13-62

Domestic and Global Diversity Course Approvals for CDFR 4303: Families and Cultural Diversity, HLTH 3002: Women's Health Across the Lifespan, EDUC 3002: Introduction to Diversity

This resolution is approved with regard to the three designated courses noted in #13-62. However, due to the limited number of courses with approved diversity designation, I direct that the implementation of the graduation requirements be delayed until a sufficient number of diversity-designated courses are available. I further request that formal faculty advice be provided by the Foundations Curriculum and Instructional Effectiveness Committee on the sufficiency of available diversity courses and be submitted to me no later than November, 2013.



**The following resolution is held for further action:**

Faculty Senate Resolution 13-57

Request that, as soon as practical, the Provost begin work to have the new academic programs (Bachelor of Science in University Studies and Bachelor of Science in University Studies distance education degree program moved into an academic college so that created coursework will not be developed outside of an academic unit

This resolution does not require an immediate response because the Bachelor of Science in University Studies program Appendix C has not been approved by UNC-GA.

Formal faculty advice on additional revisions to the *ECU Faculty Manual*, Part VII, Faculty Research and Scholarship, Section III. Regulation on Research Conduct

According to University Policy Manual Regulation 01.15.01 (Formatting, Adopting, and Publishing Policies, Regulations, and Rules), PRRs published in the University Policy Manual supersede other statements of policy that may exist elsewhere. Should any revision to the related PRR, Regulation 10.45.01 (Interim Regulation on Research Conduct), conflict with Part VII, Section III of the *ECU Faculty Manual*, the approved PRR as published prevails. Below is the applicable provision from the governing PRR.

*"4.3.2 Any electronic reproduction of a PRR by any University unit must be by hyperlink to the PRR on the East Carolina University PRR website. Units may publish web pages, handbooks, bulletins, brochures, and similar materials to provide information to faculty, staff, students and other constituent groups. To the extent that such materials reference Board of Governors or East Carolina University PRRs, with or without including the text verbatim, there must be a disclaimer that establishes the pre-eminent authority of the PRR and a reference to the location of the official PRR."*
