## East Carolina University FACULTY SENATE FULL MINUTES OF FEBRUARY 25, 2014

The sixth regular meeting of the 2013-2014 Faculty Senate was held on Tuesday, February 25, 2014, in the Mendenhall Student Center.

## Agenda Item III. Special Order of the Day

D. Ron Mitchelson, Interim Vice Chancellor for Research and Graduate Studies Interim VC Mitchelson provided the following report.

## School of the Coast Update

A draft of the proposal to create a School of the Coast at east Carolina University now exists and has already been distributed to affected units, including faculty and administration. The draft proposal has been submitted to the Chair of the Senate. There is a forum on this very topic scheduled for Wednesday (tomorrow), February 26, at 3:00 PM, in Flanagan Rm 265. We are all indebted to Dr. David Griffith for his leadership in developing the proposal and vetting it with all interested parties.
l'd like to remind everyone that the school concept is not surprisingly new and has been discussed for the past two years in accordance with the PPC recommendation of April 30, 2012 (Phase II, Number 3) to relocate centers and institutes from RGS and consider creation of a new School of the Coast. About the same time, Dr. Susan Avery, President and Executive Director of the Woods Hole Oceanographic Institute, was commissioned by RGS to evaluate ECU's coastal enterprise. She strongly recommended creation of an integrating unit because ECU's coastal intellectual capacity is fragmented across departments, schools, colleges and even entities within the UNC System. Subsequent to that Academic Council appointed a faculty task force (Jamie Kruse, Tom Allen, Reide Corbett, Bob Edwards, David Griffith, Andy Keeler, Enrique Reyes, Brad Rogers, and Tracy Van Holt) to consider ECU's coastal structure and to recommend needed adjustments. Their recommendation, to create a school of the coast as a code unit, was received in December of 2012 with feedback received during winter 2013. That report was vetted widely, including on-line survey and forum. As you
might expect "as a code unit" received the greatest attention and the most divergent opinions. At that time, Academic Council, decided that the Institute for Coastal Science and Policy (ICSP) along with the PhD program in Coastal Resource Management (CRM) should undergo external review with an eye toward strengths, weaknesses, and the School concept. That review team was with us in early February and we are now in receipt of their review, date $02 / 18 / 2014$. That external review team, while clearly stating some issues to be addressed (especially in terms of faculty governance), supports the process to plan for a School of the Coast. They see growth potential and a platform for improved governance.

I want to assure you that ECU will follow a systematic, transparent, and inclusive process in developing this proposal. David Griffith and AC are committed to no less. Ultimately, we will need approval by the UNC Board of Governors. We envision the following process:

1. Proposal is drafted for campus consideration. David Griffith has led that effort. The draft has been edited with several rounds of input. It has been endorsed by Academic Council.
2. We encourage review of this draft by all affected units. The draft has already been distributed widely. I've already seen some useful feedback. If you have not dad opportunity to examine the draft and you'd like a copy, you may certainly contact David or me. The forum on $2 / 26$ is devoted to discussion and comments on the proposal.
3. Review of proposal by the University Committee on Fiscal Sustainability.
4. Once edited to reflect common concerns, the proposal will be submitted to the EPPC. EPPC focus will be placed upon PHD program. EPPC will make a recommendation in their report to Senate.
5. The Senate will convey its recommendation to the Chancellor.
6. If appropriate, the Chancellor will submit recommendation for approval to the ECU Board of Trustees.
7. Finally, the request is submitted through UNC GA to the UNC BOG for final approval.

In sum, I believe that we have much to gain by creating a School of the Coast as currently being proposed, which is a rather simple aggregation of existing coastal assets spread across existing centers, institutes, departments and colleges. The benefits at the very least include: improved administrative efficiency (coordination), improved visibility, improved synergy and program (instructional, research, and outreach) development (collaboration), and heightened complementarity with our primary partner, the Coastal Studies Institute on Roanoke Island.

## University Committee on Fiscal Sustainability (UCFS) Update

UCFS has completed the "discovery phase" of its work, after hearing reports from units across the campus. Since I last reported, we heard from Finance \& Administration and the Division of Health Sciences. So now we are deep into developing recommendations for campus consideration. You received an invitation on February 19 to provide additional ideas on ways in which we might diversify our revenue streams or operate more efficiently. I hope you take that request seriously and invest some time in this process. I also hope that you go back to your units and encourage your colleagues to do the same. These continue to be tough times for higher education and we need all the creativity we can muster. Our target for delivering a
draft of recommendations is still mid-March. We'll receive feedback by survey and by forums on that draft.

Late last fall we invited the campus to share ideas by survey. Over 900 individuals took at least a portion of that survey, about 800 completed the entire survey. I am pleased to report that $52 \%$ of respondents (a little over 400) are faculty members. We asked about past experiences with the PPC process and any perceived changes that have been noticed since the PPC recommendations were made public (04/30/2012). For example, twenty five percent described outcomes associated with the PPC process as positive, $25 \%$ were neutral, $22 \%$ described them as negative, and $28 \%$ were unfamiliar with any outcomes. It was apparent from the commentary that we have not done a good job of communicating PPC results and actions. Having said that, last spring (2013) I did come before the Senate to describe PPC related actions taken in R\&GS. When we asked the campus about ways to increase revenues, 51 percent indicated that they had ideas but only 89 shared them with comments. Most of the comments focused on increasing grants/contracts, increasing tuition, increasing fund-raising, increasing off-model educational programs, and other entrepreneurial activities. When we asked about efficiencies and cost-savings, almost two-thirds of the respondents (about 400 in this question) said that they had ideas and about 200 shared ideas through commentary. Only one person said that we should get rid of Mitchelson. Some of the themes generated by the ECU community and highlighted in the survey results:

1. possible centralization of some business/operational services,
2. possible consolidation of some academic units,
3. possible reduction in the number of divisions,
4. possible reduction in uses of paper, energy, and water,
5. possible creation and implementation of workforce and workload policies, and
6. possible reduction in the number of under-enrolled courses and programs.

As you might imagine, this type of work is very difficult and I'm so very appreciative of the investment being made by faculty, staff, and administrators. The quality of the work will be in direct proportion to the investments we make. So thank you for participating.

## Strategic Planning Update

Good news! Our mission statement was approved by the UNC BOG last Friday. So we are free to become a national model for student success, public service, and regional transformation. The contributions that you and your colleagues make in the classrooms, the labs, with your research and with your outreach are central to achieving the mission. I am fully aware and appreciative for the sacrifices you make for our students, our region, and your disciplines.

Many of you participated in the forums and on-line surveys that sought feedback to the draft of our strategic plan. The University's Strategic Planning Committee ( 32 strong), co-chaired by Austin Bunch and Elaine Scott, has been hard at work incorporating those new ideas. Last week we brought the edited draft to the BOT. While they responded quite positively, they also expressed some concern for the breadth and size of the plan-perhaps we're planning too much. I must explain that a significant part of our volume is devoted to accomplishing the

tasks that are specified in Our Time Our Future (OTOF), which is the UNC System's strategic plan and it contains nearly 100 initiatives, most directed at every campus. The campus has provided well over 200 action items (associated with goals and objectives) and we all realize that narrowing down to a few essential projects, perhaps the School of the Coast (?), will be required to gain necessary focus.

Our next planning steps include forums with student groups-these are already scheduled. After that we will present the plan to external stake-holders for their consideration and feedback. We hope to have a modified draft in April with a target for final approval sometime in June or July.

Professor Powers (Sociology) asked how the forum on the School of the Coast was publicized and could an additional open forum be scheduled? Interim VC Mitchelson responded....

Professor Jane Patton (Allied Health Sciences) asked about SACS accreditation and had it been approved yet. Provost Sheerer replied that ECU did receive affirmation however there was a report due in the Fall in reference to the monitoring of student learning outcomes.

Professor Rigsby (Geological Sciences) expressed her agreement that ECU had been a leader in the State with work on the coast. However she was disappointed with the vague proposal that David Griffith had put forward to the University community and stated that colleagues need a detailed analysis on the impact of this proposal on resources of other science disciplines. She also stated that th David and administration may want to look back at the policy on funding CRM and how resources were agreed upon a few years ago. She stated that faculty would like better governance documents before moving forward. General Administration certainly did not request a School of the Coast but suggested that ECU get started with the planning. Interim VC Mitchelson responded that there would not be a unit code but standard operating procedures for this new School was a must.

## E. Mark Sprague, Chair of the Faculty

Professor Sprague provided the following remarks to the Faculty Senate.
It seems like we just had a Faculty Senate meeting earlier this month! Of course we did. It was our makeup January meeting that was rescheduled due to the snow. At our makeup meeting we passed Resolution \#14-08, Spring 2014 Snow Makeup Days, which recommended using Reading Day, April 30, as a makeup day for the missed Wednesday classes; April 29 (the state holiday makeup day) for the missed Thursday classes instead of the previously scheduled Friday classes; and Good Friday, April 18, as a makeup day for the Friday classes originally scheduled for April 29. The resolution recommended that the Friday classes missed due to the snow and the classes missed on partial days have no scheduled makeup time, and it and suggested ways for instructors to make up for missed classes. This resolution was based on a previous resolution for making up missed class days. Chancellor Ballard initially approved our makeup day resolution, but there was an unforeseen complication: Good Friday is a state holiday for staff. If classes are in session ECU policy requires staff to work, but staff who work on a state holiday must be paid time and a half, money we do not have in our budget. In light of this new concern, I sent Chancellor Ballard an E-mail suggesting he rescind his approval of the makeup day on Good Friday and ask that we make up the material outside class, just as we will do for other missed classes. The Chancellor has rescinded his approval of the Good Friday makeup day. An official announcement of this decision is forthcoming.

We are not asking instructors to omit material scheduled for those class days, only to make up the material outside class. We have the ability to present online material or other relevant material outside our regularly scheduled classes. In light of this, I have asked the Calendar Committee to consider a new policy on making up missed classes. The original policy is based on the assumption that the General Administration (GA) required us to make up for missed classes to meet the minimum number of contact hours in the UNC Policy Manual. GA is now allowing the use of outside activities to make up for missed classes. We need to adjust our makeup policy to allow for this possibility.

The University Committee on Fiscal Sustainability (UCFS) is considering recommendations for its draft report, which will be released in mid-March. Let me tell you that the ECU budget is complex. Our fiscal problems are real, and they are not going away in the near future. There are no magic bullets out there to save all of us from the pinch.

The UCFS gave a survey for input last fall and received over 900 responses, more than half from faculty members. The committee has carefully considered the responses and comments gathered in the survey. The committee sent an E-mail message to the campus community on February 19 asking for more input and ideas. To date, I have seen two responses to this call. It is not too late, but send your input soon. The University Budget Committee is holding a Faculty Budget Forum on March 6 from 3:30-5:00 p.m. in Bate 1028. Please encourage your colleagues to participate. We will provide minutes of the forum to the UCFS to so they can consider them when drafting their report.

At the February 4 Senate meeting Chancellor Ballard announced that Provost Sheerer will be stepping down in August. He would like to name an interim Provost by the end of the spring semester. He has asked for our thoughts about the choice. I believe that the Interim Provost will be a key person for implementing the recommendations of the UCFS. We need someone who listens to faculty advice and understands faculty issues. We need someone dedicated to academic quality. We need a leader who can build consensus while we work to preserve our university and move it forward.

There are two other items I would like to bring to your attention. The Committee on Committees is working on the slate of nominees for standing academic committees next year, and the number of volunteers as disturbingly low. Please consider volunteering, and recommend that your colleagues do the same. Our committees do most of the work of the Faculty Senate, and they would not function without you!

The Harriot College dean search is underway. The first of four candidates arrived on campus yesterday and is concluding her interview today. The other candidates will be on campus this Thursday and Friday, next Monday and Tuesday, and Thursday and Friday of next week. This is a very important position for the entire campus. I encourage you to attend the candidate presentations and provide feedback to the search committee.

I would like to thank you for all that you do to make ECU function. It always amazes me how faculty members are able to teach, do research, and find the time to participate in shared governance. You are essential to our university.

# Ofessor Martinez (Foreign Languages and Literatures) asked when the University Committee on Fiscal Sustainability will hold open forums. Professor Sprague replied.... 

Professor Gibson (Business) stated that the online Faculty Committee Volunteer Form on One Stop was not working and should be if we wish for more faculty to volunteer. Professor Sprague replied that emails to himself or the Faculty Senate office were the way to volunteer at this time.
Professor Frank (Technology and Computer Science) expressed her concern with the lack of faculty volunteers and stated that since the University was having a hard time obtaining tenured and tenuretrack faculty volunteers, maybe it was time to open committee membership up to fixed term faculty members who stand waiting and willing to serve. Professor Sprague replied that this was an idea being discussed among several standing committees.
F. Charles Boklage, UNC Faculty Assembly Delegate Professor Boklage noted that the February 14, 2014 UNC Faculty Assembly meeting did not take place due to the snow.

Chair Catherine Rigsby was invited to update the Senators on other matters being handled by the UNC Faculty Assembly. Professor Rigsby stated that the April meeting would focus on student success. She also discussed the post tenure review policy, Comprehensive Articulation Authority which is the uniformity of transfer credits from community college, and ......

Election of Five Members to the Faculty Officers Nominating Committee bllowing, ECU Faculty Manual, Part II, Section II, pg. 8, the following faculty members were elected to the Faculty officers Nominating Committee: Professor Derek Maher (Philosophy and Religious Studies), Professor Shanan Gibson (Business), Professor John Cope (Psychology), Professor Rachel Roper (Medicine), and Professor Rebecca Powers (Sociology). The committee will meet soon to begin their work and provide a slate of Faculty Officer nominees to the Faculty Senate on April 22, 2014.

## H. Question Period

Professor Jeff Popke (Geography, Planning and Environment) asked Interim VC Mitchelson about the Committee on Fiscal Sustainability and the themes being submitted thus far. He stated that he was aware of the suggestions to address underperforming academic programs and that savings would occur if eliminating faculty and staff, but with what other ways are being considered. Interim VC Mitchelson responded that there is a frequency of underperforming academic programs that would save us money, i.e. 160 1000- and 2000-courses with up to only 10 students in each course exhibits an area that we need to review.

Professor Charles Boklage (Medicine) asked, in reference to the discussion on the proposed School of the Coast, faculty governance issues and code unit status for the proposed school are expressed faculty concerns. How will Interim VC Mitchelson address these important matters. Interim VC Mitchelson stated that the proposed School of the Coast would be formed not as a code unit and faculty appointments would stay where they are.

are buying classes when they come here," Sheerer said. "Back in Pennsylvania they raised me with really tough work ethic. I think people can do more." Professor Martinez noted that the negative tone of the Provost's quoted comments calling students "customers of the university", stating that students are "buying classes" rather than recognizing that paying for a university education does much more than that, overlooks the fact that the State pays much of the tuition costs for students and research and intellectual centers that can foster public health and well-being and the comments insinuates that, by researching more instead of teaching more classes, faculty weren't doing/working as much. All of which have upset many faculty members and she was asked to obtain the Provost's comments on their concerns.

Provost Sheerer replied that she went back to the interviewer who wrote the larger interview and that she sees parents and students as customers looking for an University experience - which includes student affairs and faculty who do research, but if there are no classes offered the students suffer.

Professor Rachel Roper (Medicine) asked about the rate of sexual assault on campuses, i.e. $20 \%$ experience sexual assault their freshman year and if the Provost would an update on the campus security initiative at General Administration. Provost Sheerer noted that there will be definite recommendations that come out of these GA initiatives. For example, Title IX officer's duties are varied and need to be simplified and training is needed in all aspects of assault. Provost Sheerer noted that the GA's report is due mid-March and led by Chancellors from A\&T and NC State and she would be happy to report to the Faculty Senate on this once the report is released.

Create, in consultation with the University Curriculum Committee, a clear standard by which the Faculty Oversight Committee will be able to judge whether the proposed Bachelor of Science in University Studies (BSUS) thematic core has attempted to circumvent an existing major. The definition should take into consideration not only existing majors' major requirements but also existing majors' cognate requirements and (if applicable) foreign language requirements.
2. Define precisely what the Faculty Oversight Committee's authority and responsibility are.
3. Report to the Faculty Senate, at the first meeting of the Spring 2014 semester about the progress and implementation of the standard and authority and responsibility of the Oversight Committee.
4. Conduct a regular audit of a sample of BSUS degrees to ascertain whether the standard has been applied correctly and consistently, to recommend corrective action if the audit finds flaws or inconsistencies, and to report the audit results to the Faculty Senate at the first meeting of the spring semester of the year in which the audit is conducted.
5. The Faculty Oversight Committee should be a part of the academic program review.

Professor Stellwag then presented a report on Transmittal Letter \#86 relating to academic program planning and evaluation, noting that the Committee reviewed the Transmittal Letter \#86 dated August 27, 2013 from the University of North Carolina's Office of the Secretary relating to changes to the following items located in the UNC Policy Manual about academic program planning and evaluation:
400.1.1[R] Regulations for Academic Program Planning and Evaluation - Amended 08/26/13
400.1.1.1[G] Guidelines for Academic Program Development - Amended 08/26/13
700.4.1 - Policy on Minimum Substantive and Procedural Standards for Student Disciplinary Proceedings - Amended 08/23/13

Following the review, the Committee is reporting to the Faculty Senate that they did not see a need to propose any revisions to the ECU Faculty Manual, Part VI, Section VII in order to conform with the

Whereas, prohibiting all smoking within Dowdy-Ficklen stadium sports venues would be consistent with the ECU Mission statement.

Therefore Be It Resolved that the Faculty Senate requests the Chancellor and his administrative staff to review the smoking policies at the Dowdy-Ficklen stadium sports venues.

Professor Dudley (History) asked if this would include practiced fields, etc. Professor Rupp stated that he had in mind to protect those from second hand smoke while attending a sporting event and not really address practice fields.
