On Friday, October 31, and Saturday, November 1, ENERGY FAIR '80 will happen. The Fair will once again be held at the Willis Building (First and Reade Streets, near the Town Commons). Hours are scheduled for 10:00 a.m. to 4:00 p.m. each day.

Sponsored by The Greenville Energy Program, Greenville Utilities Commission, and other community organizations, this event will feature many ideas for energy conservation and alternative energy use. Special attractions for school groups, including an Energy Film Festival, are scheduled for Friday. Seminars on efficiency in conventional heating systems (oil, gas

and heat pump) and on using solar or wood as heat sources will be held on Saturday. Dealers in commercial energy-related products will display (but not sell) their wares. Lots of information, fun, entertainment and refreshments will be available to all who come.

Since the first ENERGY FAIR was held last January, The Greenville Energy Program has progressed in its efforts of establishing an energy management program for the Greenville area. Energy use and supplies--both conventional and alternative--have been inventoried; goals for energy management and community education have been established; and programs to accomplish those goals are being planned. Early 1981 should see the completion of our Energy Action Plan and its submission to the City Council for consideration of implementation as a planning/action document.

The Greenville Energy Program's booth at the ENERGY FAIR '80 will present information about the progress that has been made with our work over the past two years. Included will be photographs from some of our activities and information about how people can have input into the process of planning

for Greenville's energy future.

If you will be able to attend ENERGY FAIR '80, I would appreciate your assistance at the Greenville Energy Program's booth for an hour or two. Your participation would give people visiting the Fair a favorable impression of other concerned citizens working in The Greenville Energy Program.


Their realization that others are working to improve our community's energy future might encourage them to become more active in conservation efforts and to support such actions in our area.
