

The Testimony


The appearance of Albert Forrester, national co-ordinator for the **STOP NSA** Committee, before the Committee on Internal Security of the House of Representatives on July 13, 1971 was a milestone in the effort to expose the radical activities and fraudulent status of the National Student Association.

Called as a friendly witness, he was able to link the National Student Association directly to the activities of other far leftist organizations and to negotiations with the Communists in North Vietnam. It was those negotiations which precipitated the violent Mayday demonstrations in Washington, D.C. during 1971.

The testimony covers the resolutions passed by the National Student Association, condemning the United States for aggression in Vietnam, advocating free doses of heroin to addicts, calling for the liberation of all black people, defending activities of the Black Panthers and publicly indicting President Nixon for NSA defined "crimes."

Zeroing in on the educational, tax-exempt status now held by the National Student Association, Albert Forrester concluded his testimony before the Committee on Internal Security of the U.S. House of Representatives with the following remarks directed at members of the Committee:

"I simply submit to you gentlemen the fact that the National Student Association is not representative of students and should not retain its tax-exempt status, and I would certainly hope that through the efforts of each individual member of this Committee that efforts be made to remove the tax-exempt status of the National Student Association or to bring them back in line with what is Federal Law."




The Legal Brief

Realizing that NSA funds would dry up without the educational tax-exempt status currently granted to the National Student Association by the Internal Revenue Service, the STOP NSA Committee arranged for a legal brief to be prepared outlining violations of IRS statutes by the National Student Association.

After several months of intensive research the brief has been completed and is being distributed to members of Congress and to officials within the Internal Revenue Service. The brief, running more than 15 pages in length, explains how the National Student Association is unqualified for such a status because it has violated both the intent and the letter of the law.

Initial reaction to the brief from Congressmen and Senators has been encouraging and IRS officials conducting the investigation into the National Student Association were pleased to receive the information.

A major effort, the legal brief may prove the most valuable tool yet if indeed the IRS rightfully withdraws the educational tax status classification from the National Student Association.



The News Conference

In order to increase public awareness of the manner in which the National Student Association has not only been in the forefront of radical leftist disruptions but has also financed these activities with funds received from tax-exempt foundations, Albert Forrester called a news conference in Washington, D.C. on March 15, 1972.



At the conference he made public the legal brief and challenged the news media to give publicity to the tax-exempt fraud being perpetrated by the officers of the National Student Association. Furthermore he urged members of Congress and especially officials of the Internal Revenue Service to take immediate action to protect the interests of both the students and American taxpayers who have been "paying the bill" for the radical activities of the National Student Association.

He indicated that prompt action on this very serious matter would save the taxpayers money, it would add credibility to government and it would make the National Student Association "stand on its own" as an independent radical student organization ineligible for huge grants from tax-exempt foundations.
