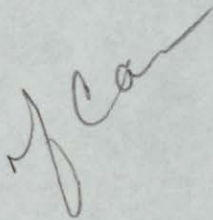

I do not support the creation of significant new wilderness areas in Western North Carolina. I favor the multiple use of the National Forests in North Carolina. I do not feel that the Forest Service's management has neglected the protection of these lands. It is worth noting that almost all the areas currently under consideration for wilderness designation have been heavily timbered at one time or another, and have recovered very well. Many areas within the National Forests that contain rare plants or animals are being administratively protected by the Forest Service. In some cases, wilderness designation would prevent the management of habitats that is necessary to insure the continued survival of threatened species. Preventing use of substantial areas of land could well intensify the pressures on the remaining lands, and thus frustrate the overall goal of environmental protection.

I do not support the creation of more Wilderness Areas in Western North Carolina. I feel that the National Forest lands in the State should be open to multiple uses, and not limited solely to wilderness camping. The citizens of Western North Carolina depend on the National Forests for income, jobs, and recreation. I think the Forest Service has done an admirable job in protecting these lands from overuse and despoilation, as evidenced by the fact that most of the areas under consideration for Wilderness were once heavily logged.
