

## Dear Dr. Maier:

Thank you for a most informative and enjoyable visit on December 16th. We were most pleased to hear of the positive recommendation for an Army ROTC Program contained in the East Carolina University (ECU) Planning Commission's report and stand ready to assist in any way possible to help obtain final approval on campus.

As we discussed during our visit, the first step in obtaining an Army ROTC Program on campus is completion of a Cross-Enrollment Agreement for the Establishment of an Army Reserve Officers' Training Corps Program. A model agreement is attached as an inclosure. The Chancellor, or Acting Chancellor, as may be appropriate, should sign on behalf of ECU and the agreement should then be returned to Lieutenant Colonel Pitcher or myself for completion. It should be noted that this item is particularly important since it provides the basis for the actual commitment of Army resources to the new program. Completion in a timely manner would be most appreciated to give us as much lead time as possible.

BG Adams also plans to recommend ECU for host status under the Expand-the-Base Program to Headquarters Training and Doctrine Command. If approved, host status will be granted effective 1 October 1982. I will keep you posted on the progress of this action.

Again, my thanks for the warm reception and productive session with Dr. Volpe and yourself this past week. I hope you have a most enjoyable holiday season.

## CROSS-ENROLLMENT AGREEMENT

## CROSS-ENROLLMENT AGREEMENT FOR THE ESTABLISHMENT OF ARMY RESERVE OFFICERS' TRAINING CORPS INSTRUCTION AT EAST CAROLINA UNIVERSITY, GREENVILLE, NC

1. Under the provisions of Public Law 88-647, and Section 2102, Title 10, United States Code, a Senior ROTC unit was established at Campbell University, Buies Creek, NC, effective 2 February 1971. This ROTC unit was established pursuant to an agreement between the governing authorities of Campbell University, signed by Dr. Norman A. Wiggins, President, and approved for the Secretary of the Army by MG Kenneth G. Wickham, TAG, Department of the Army, on 22 January 1971. Copies of the agreement are on file at Campbell University and at the Department of the Army.

2. The CROSS-ENROLLMENT AGREEMENT between Campbell University and East Carolina University is entered into pursuant to the above authorities, and Army Regulation 145-1 which authorize the cross-enrollment of students between host ROTC and non-ROTC institutions.

3. Contingent upon the acceptance of this AGREEMENT by both parties, Campbell University agrees to the following:

a. To provide Senior Division Academic Instruction of the Army Reserve Officers' Training Corps on the campus of East Carolina University if minimum enrollment figures are achieved. Such instruction will be available to all qualified students.

b. To provide such military personnel as may be required for the necessary and proper conduct of Army Reserve Officers' Training Corps instruction at East Carolina University subject to the availability of military personnel from US Army resources.

c. To provide for use in the Army Reserve Officers' Training Corps instructional program at East Carolina University such available US Government property as may be authorized by law and applicable tables of allowances.

d. To issue, at the expense of the US Government, textbooks for students enrolled in the ROTC program, for courses taught by military instructors. Title to these books remain with the US Government.

e. To provide grade reports to the East Carolina University Registrar for each student enrolled in courses taught by military instructors, in accordance with the procedure and timing desired by East Carolina University.

4. Contingent upon the acceptance of the above provisions, East Carolina University agrees to the following:

a. To adopt as a part of its curriculum, a course of Senior Division Reserve Officers' Training Corps instruction. This curriculum will be developed in coordination with the Professor of Military Science at Campbell University in accordance with current Army Regulations and directives. b. To recognize the senior military officer assigned to Campbell University as Professor of Military Science and all ROTC personnel giving instruction at East Carolina University as members of the faculty.

c. To arrange for the scheduling of military classes at times agreeable to the Professor of Military Science, Campbell University, and to include a representative of the Department of Military Science of Campbell University designated by the Professor of Military Science of Campbell University on those committees whose recommendations would directly affect the conduct of this program.

d. To enroll all East Carolina University students who desire to enroll in ROTC and who meet the eligibility requirements for ROTC enrollment as set forth in Army Regulation 145-1, and upon whose enrollment the Professor of Military Science concurs.

e. To grant academic credit applicable towards graduation for successful completion of courses offered by the Department of Military Science.

f. To provide student classroom rosters and all mid-term and final grades of students enrolled in military science courses to the Military Science Department, Campbell University, on the same basis as provided other departments at East Carolina University.

g. To make available at East Carolina University without charge to Campbell University or the United States Army, the necessary classrooms, administrative offices, storage space, government vehicle parking space, staff parking space, and other required facilities in the same manner and at the same level as is provided to other departments within the institution.

h. To provide adequate secretarial, janitorial, and communication services; printing and publications; building maintenance, utilities and grounds upkeep at no expense to Campbell University or the United States Army.

i. To provide for the protection of all public property used in support of the ROTC program and to take all reasonable measures within the power of East Carolina University to recover US Government property which is improperly in the hands of students or former students, which may include withholding transcripts of grades or certificates of graduation upon request of the Professor of Military Science.

j. To place four students into the MS III program of the host institution within two years after activation. Failure to achieve these minimums shall result in a notice of program termination.

5. It is mutually understood and agreed as follows:

m.t.

a. The Professor of Military Science will issue, at the expense of the US

Government, to all students enrolled in ROTC, uniforms, textbooks, and other equipment necessary for the conduct of ROTC instruction. Title to issued property remains with the US Government. Students are required to return issued property in clean and serviceable condition upon completion of the course of instruction. b. If in any semester minimum enrollment of qualified MS III students at East Carolina University is not achieved, the program at East Carolina University will be discontinued. However, those students who have signed contracts will be given the opportunity to complete the ROTC program.

c. This AGREEMENT shall become effective when approved and signed by the appropriate authorities at each institution.

d. Final authority to conduct ROTC instruction at East Carolina University is vested in the Commander, First ROTC Region.

e. During School Year 1982-3 (Fall Semester), two courses of military science (first and third years) will be offered by Campbell University. Second and fourth year courses will be added in SY 1983-4.

f. East Carolina University may charge tuition fees for ROTC courses for which academic credit is awarded (whether by the term or by the credit hour), provided that tuition fees charged for ROTC are not greater than those charged for other courses at East Carolina University.

g. East Carolina University ROTC students will have equal opportunity with Campbell University students to compete for three, two and one-year ROTC scholarships.

h. This AGREEMENT may be terminated upon giving written notice of such intent by either party concerned, one academic year prior to the actual termination.
