

Attorney General Robert Morgan

Mr. Morgan numbers among his employees approximately a dozen who are of Jaycee age. Of that dozen, Assistant Attorney General Sidney Eagles is a Vice President of the Raleigh Jaycees and Burley Mitchell, Jr. is a newly elected Director of the Raleigh Jaycees. Ted Eatman is Chairman of the Constitution and Bylaws Committee. The other members are active as well. Only through Mr. Morgan's approval of their activities in the Raleigh Jaycees can these young men continue their active participation in the affairs of the Raleigh Jaycees.

Among his direct contributions to the Jaycees are his personal support and interest in projects of the Raleigh Jaycees, projects of Harnett County Jaycee organizations and his direct contributions in the form of appearing and speaking at Distinguished Service Award and Bosses' Night presentations throughout the State. In 1970, Mr. Morgan delivered the principle address at more than eight Distinguished Service Award presentations in North Carolina. He participated in the 1970 Jaycee Legislative Day program and has appeared before numerous Jaycette programs. In 1970, he gave the DSA address in Asheboro, Smithfield, Jacksonville, Jamestown, Statesville, Wilson and Cary, as well as Jaycee programs in Gastonia, Thomasville and Wendell.

In the field of contributions to community welfare and betterment, Mr. Morgan's efforts in the creation, staffing and energetic leadership of the State Attorney General's Office and its Consumer Protection Division have constituted regular and continuing contributions of substantial nature. In the area of elimination of deceptive trade and business practices by unsavory "fly-by-night" business groups, Mr. Morgan has initiated intervention on behalf of the consumer in Milk Commission hearings to require the Milk Commission to refrain from retail price setting of milk, intervention in pending general rate cases before the Utilities Commission involving the major telephone and electric power companies in North Carolina, and participation in a multi-state anti-trust suit in the federal courts against drug companies convicted of conspiracy to fix prices of certain broad spectrum antibiotics.

Mr. Morgan is an active member of numerous civic organizations. He is an active member of the Masons, the American Legion, the Veterans of Foreign Wars and the Rotary Club of Lillington. He is a Major in the Air Force Reserve. In addition to his vigorous activity as a member of these organizations, he has spoken before civic clubs and groups throughout the State on a continuing basis. On an average month, he has between 25 and 40 speaking engagements—a full three-quarters of these being before civic groups in the local communities of North Carolina.

Among the contributions to the State which Mr. Morgan has made which will continue as a reminder of his work is the Consumer Protection Division of the Attorney General's Office created by statute in the Attorney General's Office in the 1969 General Assembly and the excellent results which this Division has accomplished.

Mr. Morgan is a veteran of 14 years of public service. He served one term as Clerk of Superior Court of Harnett County and five terms as a State Senator representing his district. During the 1965 Session he was elected President Pro Tem of the Senate. In 1968 he ran, was nominated and elected Attorney General of North Carolina, overcoming opposition in both the primary and the general elections.

In addition to his governmental activities he has served six one-year terms as Chairman of the Board of Trustees of East Carolina University.

Concerning cooperation with individuals in other civic organizations, Mr. Morgan and his wife have lent their name and prestige to numerous charitable campaigns, including the 1970 and 1971 Easter Seals Campaign and the 1970 Cystic Fibrosis State Campaign. These activities are just one measure of his dedication to various charities and civic organizations.

By way of additional cooperation with local Jaycee organizations, he has furnished speakers from his attorney staff to the State Jaycee Law and Order:Crime Prevention Project. Under this project approximately 75 chapters from
