## ANNOUNCEMENT OF CHARLES WINBERRY AS CAMPAIGN MANAGER

I said a little earlier in my statement that I am extremely optimistic about the campaign and the way things have been going. There are a lot of reasons why this is true but none quite as important as the fact that we already have on the job and working hard the best campaign manager any candidate in this State could ever ask for.

I am delighted to tell you Charles B. Winberry, Jr., has consented to be our campaign manager.

Many of you already know Charlie through your association with him as a young leader of the Democratic Party in North Carolina.

Allow me to tell you some things about him anyway.

Charlie is a native of Statesville and attended both undergraduate and law school at Wake Forest University.

While a student at Wake Forest, he was a dynamic student leader whose influence extended far beyond the Wake Forest campus. A number of his classmates are here today, and I know they could testify to that fact.

After graduation from law school, Charlie served as a law clerk to U.S. District Judge John D. Larkins, Jr., and then as Chief Prosecutor of the seventh Judicial District in Wilson.

Charlie has now settled in Rocky Mount and is a partner in one of the State's best law firms, Biggs, Meadows, Batts and Winberry.

Though still a young man, Charlie Winberry can match political experience with most people twice his age.

He has served as President of the North Carolina Young Democratic Clubs and Vice-Chairman of the State Democratic Executive Committee.

Charlie accomplished one feat almost unheard of

in North Carolina political history. He was elected without opposition as Chairman of the Democratic Committee in Nash County during the first year he lived there. He now has resigned to manage our campaign.

When I ran for the office of Attorney General the first time in 1968, Charlie Winberry came to Lillington and was part of our team. He was with us again, working hard, in 1972.

So, nothing could please me more than to announce to you today that this dynamic, aggressive young man will be heading our United States Senate campaign team in 1974.

I know you're going to enjoy working with Charlie Winberry.

Team very pleased to be here today, especially to introduce the new head football coach at East Carolina---Pat Dye, who is our guest of honor.

After careful and long screening, Pat was appointed by President Jenkins to succeed Coach Sonny Randle last December, who, as you know, left to head the football program at the University of Virginia.

North Carolina is extremely lucky to have such a standout in football as Pat Dye, for he is known for being a stick-with-it type of guy, who gets the most out of what he has from the players on the field.

Pat comes to ECU from the University of Alabama, where he was an assistant coach under the legendary Paul "Bear" Byrant, and from where winning is a tradition. Being part of such a superb football program is in itself a tribute to excellence, both on the field and off, and I feel sure that Pat Dye will bring to East Carolina that excellence exemplified by the record of the Crimson Tide.

I want you to know, also, that Pat is indeed a loyal coach, for even after signing with East Carolina last year, he went back to Alabama to help guide the team through the Sugar Bowl against Notre Dame. He certainly doesn't leave a job unfinished.

As a player, Pat Dye accomplished much to proud of: He lettered three years in football at the University of Georgia from 1958 to 1960; was All America and All Southeastern Conference two years in 1959 and 1960; and played professional football two years in the

Canadian Football League as a corner linebacker.
