ADMINISTRATION, THE UNITED STATES MARSHALS SERVICE, THE BUREAU OF

PRISONS, AND THE CRIMINAL DIVISION OF THE DEPARTMENT.

THOUGH I SPEAK WITH HIGH PRAISE OF MR. CIVILETTI, I MUST AT THIS

TIME PAUSE TO GIVE SOME CREDIT FOR HIS SUCCESS TO A GOOD TEACHER. HE

WAS PRIVILEGED TO SERVE UNDER AND WORK DIRECTLY WITH MY GOOD FRIEND,

THE HONORABLE GRIFFIN BELL. I CAN SAY IN ALL CANDOR THAT I HAVE

NEVER BEEN ASSOCIATED WITH A WARMER, MORE UNDERSTANDING AND TALENTED PUBLIC SERVANT. I STILL COUNT IT A GREAT HONOR TO HAVE BEEN ABLE TO INTRODUCE GRIFFIN BELL TO THIS SAME GROUP IN CHARLOTTE, AND I TREASURE THE OPPORTUNITIES WE HAD TO WORK TOGETHER IN WASHINGTON.

SINCE OUR SPEAKER WAS APPOINTED THE NATION'S CHIEF LAW OFFICER IN THE SUMMER OF 1979, UPON THE RESIGNATION OF THEN ATTORNEY GENERAL Bell, I have had opportunities to talk with him on a number of OCCASIONS. EACH TIME HE HAS BEEN MORE THAN HELPFUL, AND EACH TIME I HAVE BEEN IMPRESSED BY HIS SINCERITY AND HIS DEDICATION TO THE POSITION HE HOLDS. I HAVE THE FEELING, AND I HOPE THAT TIME SHALL PROVE ME CORRECT, THAT ATTORNEY GENERAL CIVILETTI UNDERSTANDS THE NEED TO REDRESS THE GROWING INBALANCE BETWEEN THE FEDERAL GOVERNMENT AND THE VARIOUS STATES.
